



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Jeff Chua
DOCKET NO.: 08-06717.001-R-1

The parties of record before the Property Tax Appeal Board are Jeff Chua, the appellant; and the Will County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds a reduction in the assessment of the property as established by the Will County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$21,000
IMPR.: \$73,186
TOTAL: \$94,186

Subject only to the State multiplier as applicable.

ANALYSIS

The subject property is improved with an owner occupied residential property located in Wheatland Township, Will County, Illinois.

The appellant submitted evidence before the Property Tax Appeal Board claiming the subject's assessment was incorrect based on contention of law. The evidence disclosed the subject property was the subject matter of an appeal before the Property Tax Appeal Board the prior year under docket number 07-00276.001-R-1. In that appeal the Property Tax Appeal Board rendered a decision lowering the subject's assessment to \$94,186 based on the evidence submitted by the parties. Based on this evidence, the appellant requested a reduction in the subject's to \$96,186.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's assessment of \$105,453 was disclosed. The board of review acknowledged receipt of the 2007 Property Tax Appeal Board decision lowering the subject's assessment. The board of review indicated the subject's assessment is entitled to a "rollover" of the Board's prior

year's decision and the 2008 township multiplier was 1.0000. Thus, the board of review requested the subject's assessment be reduced to \$94,186.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Board further finds a reduction in the subject's assessment is warranted.

Pursuant to section 16-185 of the Property Tax Code (35 ILCS 200/16-185), the Board finds the prior year's decision should be carried forward to the subsequent assessment year subject only to equalization. Section 16-185 of the Property Tax Code provides in pertinent part:

If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel on which a residence occupied by the owner is situated, such reduced assessment, subject to equalization, shall remain in effect for the remainder of the general assessment period as provided in Sections 9-215 through 9-225, unless that parcel is subsequently sold in an arm's length transaction establishing a fair cash value for the parcel that is different from the fair cash value on which the Board's assessment is based, or unless the decision of the Property Tax Appeal Board is reversed or modified upon review. (35 ILCS 200/16-185).

The record disclosed the Property Tax Appeal Board rendered a decision reducing the subject property's 2007 assessment and the subject property is an owner occupied. This record contains no evidence indicating the subject property sold in an arm's-length transaction subsequent to the Board's decision or that the assessment year in question is in a different general assessment period. For these reasons the Property Tax Appeal Board finds that a reduction in the subject's assessment is warranted commensurate with the assessment amount as outlined by the board of review.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
