



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Tal Izraeli

The parties of record before the Property Tax Appeal Board are Tal Izraeli, the appellant, by attorney David C. Dunkin, of Arnstein & Lehr in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$12,474
IMPR.: \$70,180
TOTAL: \$82,654

Subject only to the State multiplier as applicable.

ANALYSIS

The subject property is improved with a class 2-11 2-story multi-family dwelling of masonry construction containing 2,384 square feet of living area. The building is 116 years old. Features of the building include a full basement with finished area, central air conditioning and a 2-car garage. The property has a 3,125 square foot site and is located in Chicago, Lakeview Township, Cook County.

The appellant's appeal is based on assessment equity. The appellant submitted information on six comparable properties described as 2 or 3-story multi-family dwellings of frame or masonry construction that range in size from 2,004 to 2,694 square feet of living area. The dwellings range in age from 98 to 114 years. Each comparable has the same neighborhood code as the subject property. The comparables feature garages that range in size from 1 to 3 cars. Five comparables feature full basements, one with finished area, and one is on a crawl-space foundation. Two comparables feature central air conditioning. The comparables have improvement assessments ranging from \$40,124 to \$63,441 or from \$16.73 to \$24.12 per square foot of living area. The subject's improvement assessment is \$70,180 or \$29.44 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment to \$51,637 or \$21.66 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment was disclosed. The board of review presented descriptions and assessment information on four comparable properties improved with 2-story multi-family dwellings of masonry construction that range in size from 2,434 to 3,328 square feet of living area. The dwellings range in age from 100 to 108 years. Each has the same neighborhood code as the subject property. Features of the comparables include full basements, one with finished area, and 2-car garages. Two comparables feature central air conditioning and three have fireplaces. These properties have improvement assessments ranging from \$71,851 to \$78,726 or from \$23.66 to \$29.52 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Board further finds a reduction in the subject's assessment is not warranted.

The appellant contends unequal treatment in the subject's improvement assessment as the basis of the appeal. Taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessments by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989); 86 Ill.Admin.Code 1910.63(e). The evidence must demonstrate a consistent pattern of assessment inequities within the assessment jurisdiction. After an analysis of the assessment data, the Board finds the appellant has not met this burden.

The Board finds the appellant's comparables #1, #2, #5 and #6 and the board of review comparable #4 differ substantially from the subject in style, exterior construction, size and/or foundation. The appellant's comparables #3 and #4 and the board of review comparables #1, #2 and #3 are the most similar to the subject in location, size, style, exterior construction, features and age. Due to their similarities to the subject, these comparables received the most weight in the Board's analysis. These comparables had improvement assessments that ranged from \$18.98 to \$29.52 per square foot of living area. The subject's improvement assessment of \$29.44 per square foot of living area falls within the range established by the best comparables in this record. Based on this record the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement assessment was inequitable and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
