



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Urooj Khan

The parties of record before the Property Tax Appeal Board are Urooj Khan, the appellant(s), by attorney Dennis M. Nolan, of Dennis M. Nolan, P.C. in Bartlett; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND: \$42,750  
IMPR: \$133,949  
TOTAL: \$176,699**

Subject only to the State multiplier as applicable.

**ANALYSIS**

The subject property consists of a 6,250 square foot parcel of land improved with an 18-year old, one-story, commercial building containing 3,200 square feet of building area. The appellant, via counsel, argued that the market value of the subject property is not accurately reflected in the property's assessed valuation as the basis of this appeal.

In support of the market value argument, the appellant submitted descriptions and sales information on three properties. The properties range in age from 2 to 10 years and contain between 5,096 and 9,014 square feet of building area. These properties sold from July 2006 to October 2007 for prices ranging from \$500,000 to \$1,049,097 or from \$98.12 to \$116.39 per square foot

of building area, including land. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's total assessment of \$176,699 was disclosed. This assessment reflects a fair market value of \$464,997 or \$156.25 per square foot of building area when the Cook County Real Property Assessment Classification Ordinance level of assessments of 38% for Class 5a properties is applied.

In support of the subject's assessment, the board of review presented descriptions and sales information on a total of 3,300 square feet of building area and sold from August 1998 to March 2009 for prices ranging \$425,000 to \$1,200,000 or \$138.84 to \$400.00 per square foot of building area, including land. In addition, the board of review submitted a copy of the trustee's deed showing the subject sold in September 2008 for \$500,000.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal.

When overvaluation is claimed the appellant has the burden of proving the value of the property by a preponderance of the evidence. National City Bank of Michigan/Illinois v. Illinois Property Tax Appeal Board, 331Ill.App.3d 1038 (3<sup>rd</sup> Dist. 2002); Winnebago County Board of Review v. Property Tax Appeal Board, 313 Ill.App.3d 179 (2<sup>nd</sup> Dist. 2000). Proof of market value may consist of an appraisal, a recent arm's length sale of the subject property, recent sales of comparable properties, or recent construction costs of the subject property. 86 Ill.Admin.Code 1910.65(c). Having considered the evidence presented, the PTAB concludes that the evidence indicates a reduction is not warranted.

The Board finds the best evidence of the subject's market value is its sale in September 2008 for \$500,000. The Board further finds the subject assessment is supported by the comparables as well as the subject's sale. Therefore, the Board finds that the appellant has failed to establish by a preponderance of the evidence that the subject is overvalued and a reduction is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
