



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Randy Barone, the appellant, by attorney Terrence Kennedy Jr. of Law Offices of Terrence Kennedy Jr., in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$16,087
IMPR.: \$70,941
TOTAL: \$87,028

Subject only to the State multiplier as applicable.

ANALYSIS

The subject property consists of a one-story light industrial building of masonry construction containing 4,500 square feet of building area. The building was built in 1941. The subject is classified as a class 5-93 industrial property under the Cook County Real Property Assessment Classification Ordinance and is situated on a 6,875 square foot lot located in Jefferson Township, Cook County.

The property in this appeal was the subject of appeals before the Property Tax Appeal Board for the prior years under Docket Nos. 06-27992.001-I-1 and 07-28476.001-I-1. In each appeal, the Property Tax Appeal Board reached a decision based upon the evidence in the record as presented by the parties to the appeal. Pursuant to the Official Rules of the Property Tax Appeal Board, evidence from both parties in support of their respective opinions of the subject's market value as of the assessment date or equity of the assessment was requested. In those appeals,

(Docket Nos. 06-27992.001-I-1 & 07-28476.001-I-1) the Property Tax Appeal Board issued decisions based on the evidence submitted reflecting assessments of \$87,028 for each appeal.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Property Tax Appeal Board finds from its analysis of the record that the evidence in this appeal is no different from that of the prior years. Since no new evidence was presented to warrant a change from the previous years' decisions, the Board finds that the assessment as established in the prior years' appeal is appropriate.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
