



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Bradley Pausha

The parties of record before the Property Tax Appeal Board are Bradley Pausha, the appellant, by attorney Julie Realmuto, of McCarthy Duffy in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND: \$ 10,000
IMPR.: \$ 28,543
TOTAL: \$ 38,543**

Subject only to the State multiplier as applicable.

ANALYSIS

The subject consists of a 3,125 square foot parcel of land improved with a one and half-story, single-family dwelling of frame construction. The dwelling is 111 years old. Features of the home include a full unfinished basement, central air conditioning, one full bathroom and a two-car garage.

The appellant's appeal is based on unequal treatment in the assessment process. The appellant submitted information on four comparable properties described as single-story, single-family frame dwellings that range in age from 99 to 109 years old. The comparable dwellings range in size from 660 to 731 square feet of living area. Features include an unfinished basement and one full bathroom. The appellant did not include any data concerning garages for the comparables. The comparables have improvement assessments ranging from \$33.85 to \$35.12 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's total assessment of \$38,543 was disclosed. The subject's improvement assessment is \$28,543 or \$28.57 per square foot of living area. The board of review presented descriptions and assessment information on four comparable properties consisting of one and half-story, frame

single-family dwellings that range in age from 98 to 116 years old. The dwellings range in size from 884 to 999 square feet of living area. Features include a full unfinished basement, a two-car garage and air conditioning and a fireplace for one property. These properties have improvement assessments ranging from \$32.68 to \$34.03 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Board further finds a reduction in the subject's assessment is not warranted.

The appellant contends unequal treatment in the subject's improvement assessment as the basis of the appeal. Taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). After an analysis of the assessment data, the Board finds the appellant has not met this burden.

The first issue before the Board is the correct square footage attributable to the subject improvement. The Board finds that the appellant failed to substantiate the claim that the subject's square footage is different than the public record presented by the board of review. Consequently, the Board finds the subject contains 999 square foot of living area. The subject improvement is \$28.57 per square foot of living area based on 999 square feet.

The Board finds the comparables submitted by the board of review are most similar to the subject in location, size, style, exterior construction, features and age. Due to their similarities to the subject, these comparables received the most weight in the Board's analysis. These comparables had improvement assessments that ranged from \$32.68 to \$34.03 per square foot of living area. The subject's improvement assessment of \$28.57, based on 999 per square foot of living area, is below the range established by the most similar comparables. After considering adjustments and the differences in both parties' comparables when compared to the subject, the Board finds the subject's improvement assessment is equitable and a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
