



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Imir Arifi  
DOCKET NO.: 10-01621.001-R-1  
PARCEL NO.: 09-11-225-033

The parties of record before the Property Tax Appeal Board are Imir Arifi, the appellant; and the DuPage County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds a reduction in the assessment of the property as established by the DuPage County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$65,830  
**IMPR.:** \$34,010  
**TOTAL:** \$99,840

Subject only to the State multiplier as applicable.

**ANALYSIS**

The subject property is improved with a one-story dwelling of frame and masonry construction containing 1,257 square feet of living area. Features of the home include a partial walkout basement that is 25% finished, central air conditioning, a fireplace and a 440 square foot garage. The dwelling was built in 1959. The property is located in Downers Grove Township, DuPage County.

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. In support of this overvaluation argument the appellant submitted a settlement statement, a sales contract and a multiple listing service (MLS) sheet for the recent sale of the subject property. The appellant also completed Section IV-Recent Sales Data of the Residential Appeal form. The recent sales data revealed that the subject property was purchased in October 2009 for a price of \$300,000. The data also revealed that the subject was exposed to the market by a realtor through a multiple listing service for 136 days. The sale was not a transfer between family or related party. Based on this evidence the appellant requested the

subject's assessment be reduced to reflect the subject's sale price.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment of \$173,730 was disclosed. The subject's assessment reflects an estimated market value of \$522,025 using DuPage County's 2010 three-year median level of assessments of 33.28%.

In support of the subject's assessment, the board of review submitted three sales, one of which is located in the same neighborhood code as the subject as assigned by the local assessor. The comparables were described as being improved with one-story dwellings of frame, masonry or frame and masonry construction containing from 1,196 to 1,257 square feet of living area. The dwellings were built from 1958 to 1960. Two homes feature full basements, one of which is 25% finished and one home has a partial basement that is 25% finished. Other features include a fireplace and garages ranging in size from 440 to 654 square feet of building area. Information regarding whether the comparables have central air condition was not disclosed in the board of review's grid analysis. The sales occurred from January 2007 to June 2009 for prices ranging from \$430,000 to \$475,000 or from \$345 to \$397 per square foot of living area, including land. The board of review also included the Illinois Real Estate Transfer Declaration for the sale of the subject property. Based on this evidence, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Board further finds the evidence in the record supports a reduction in the subject's assessment.

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. National City Bank of Michigan/Illinois v. Illinois Property Tax Appeal Board, 331 Ill.App.3d 1038 (3<sup>rd</sup> Dist. 2002). Proof of market value may consist of an appraisal of the subject property, **a recent sale**, comparable sales or construction costs. (86 Ill.Admin.Code §1910.65(c)). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The Board finds the best evidence of market value in the record is the sale of the subject property in October 2009 for \$300,000. The Illinois Supreme Court has defined fair cash value as what the property would bring at a voluntary sale where the owner is ready, willing, and able to sell but not compelled to do so, and the buyer is ready, willing and able to buy but not forced to do so. Springfield Marine Bank v. Property Tax Appeal Board, 44 Ill.2d. 428, (1970). A contemporaneous sale of property between

parties dealing at arm's-length is a relevant factor in determining the correctness of an assessment and may be practically conclusive on the issue of whether an assessment is reflective of market value. Rosewell v. 2626 Lakeview Limited Partnership, 120 Ill.App.3d 369 (1<sup>st</sup> Dist. 1983), People ex rel. Munson v. Morningside Heights, Inc, 45 Ill.2d 338 (1970), People ex rel. Korzen v. Belt Railway Co. of Chicago, 37 Ill.2d 158 (1967); and People ex rel. Rhodes v. Turk, 391 Ill. 424 (1945).

There is no evidence in this record that the subject's sale was not an arms-length transaction. The Board finds the subject was sold by a realtor, Richard Roudebush, after 136 days of market exposure time through a multiple listing service. The transfer was not between family or related corporations. The Board further finds the subject's assessment reflects a market value greater than the subject's sale price presented by the appellant. Based on this record the Property Tax Appeal Board finds the subject property had a market value of \$300,000 as of January 1, 2010 and a reduction in the subject's assessment is justified. Since fair market value has been established, the three-year median level of assessment for DuPage County of 33.28% shall apply.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
