



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Wladyslaw Lenczewski

The parties of record before the Property Tax Appeal Board are Wladyslaw Lenczewski, the appellant, by attorney Scott Shudnow of Shudnow & Shudnow, Ltd., Chicago; and the DuPage County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds a reduction in the assessment of the property as established by the DuPage County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$26,370  
**IMPR.:** \$15,760  
**TOTAL:** \$42,130

Subject only to the State multiplier as applicable.

**ANALYSIS**

The subject property is improved with a tri-level single family dwelling of partial brick construction that contains 1,036 square feet of living area. The dwelling is approximately 50 years old. Features of the home include a partial finished basement, central air conditioning and a two-car attached garage. The subject has a 8,400 square foot site and is located in Addison, Addison Township, DuPage County.

The record disclosed the subject property is an owner occupied residence that was the subject matter of an appeal before the Property Tax Appeal Board for the 2009 tax year under Docket Number 09-03382.001-R-1. In that appeal the Property Tax Appeal Board rendered a decision lowering the assessment of the subject property based on an agreement of the parties to \$46,330.

The appellant is challenging the assessment for the 2010 tax year on the basis of overvaluation. In support of this argument the appellant provided evidence disclosing the subject property was purchased on December 12, 2008 for a price of \$139,000. The evidence disclosed the parties to the transaction were not related and the property was exposed on the open market with a

Realtor for eight months. The appellant also submitted a copy of an appraisal estimating the subject property had a market value of \$135,000 as of January 1, 2009. Additionally, the appellant submitted a copy of the board of review decision disclosing a total assessment of \$73,660, which reflects a market value of approximately \$221,000 when applying the statutory level of assessments. Based on this evidence the appellant requested the subject's assessment be reduced to \$45,000 to reflect the appraised value.

The board of review did not timely submit its "Board of Review Notes on Appeal" and evidence in support of the assessed valuation of the subject property. The record disclosed that for 2010 Addison Township had an equalization factor of .90940.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. Pursuant to section 16-185 of the Property Tax Code (35 ILCS 200/16-185), the Board finds its decision for tax year 2009 should be carried forward to the 2010 tax year subject only to equalization.

Section 16-185 of the Property Tax Code (35 ILCS 200/16-185) provides in part:

If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel on which a residence occupied by the owner is situated, such reduced assessment, subject to equalization, shall remain in effect for the remainder of the general assessment period as provided in Sections 9-215 through 9-225, unless that parcel is subsequently sold in an arm's length transaction establishing a fair cash value for the parcel that is different from the fair cash value on which the Board's assessment is based, or unless the decision of the Property Tax Appeal Board is reversed or modified upon review.

The record disclosed the Property Tax Appeal Board issued a decision reducing the subject's assessment for the 2009 tax year to \$46,330. The record further indicates that the subject property is an owner occupied dwelling. Pursuant to section 1910.90(i) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code 1910.90(i)) the Board also takes notice tax years 2007 through 2010 are within the same general assessment period for DuPage County. (See 35 ILCS 200/9-215). The record contains no evidence that the subject property sold subsequent to the Board's decision for the 2009 tax year establishing a different fair cash value from which the Board's decision was based. Additionally, there was no evidence that the decision of the Property Tax Appeal Board for the 2009 tax year was reversed or modified upon review. The Board further finds that for tax year 2010 an equalization factor of .90940 was applied in Addison Township. Based on this record and pursuant to section 16-185 of the Property Tax Code the Property Tax Appeal Board finds a

reduction in the subject's assessment is justified to reflect the Board's decision for the 2009 tax year plus the application of the equalization factor.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
