



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Colleen Delaney

The parties of record before the Property Tax Appeal Board are Colleen Delaney, the appellant; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds a reduction in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$1,188
IMPR.: \$10,434
TOTAL: \$11,622

Subject only to the State multiplier as applicable.

ANALYSIS

The subject property consists of one residential condominium unit located in a 56-year old, 24-unit, residential condominium building.

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. In support of this overvaluation argument the appellant submitted a copy of a settlement statement indicating the subject sold on April 17, 2009 for \$130,000. The appellant's pleadings indicate the subject property was advertized for sale and that the transfer of the property was not between family or related corporations. In addition, the appellant submitted an appraisal by Gregory Ray Tredup. The appraiser indicated the subject's market value was \$135,000 on March 10, 2009. Based on this evidence the appellants requested the subject's assessment be reduced to reflect the subject's purchase price.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's total assessment of \$15,798 was disclosed. This assessment reflects a market value of \$176,711 using the Illinois Department of Revenue's 2010 three year median level of assessment for class 2 property of 8.94%. In support of

the subject's assessment, the board of review submitted a memo that included raw sales data for recent sales of units within the subject building. The memo lists the Permanent Index Number, deed number, sale date, sale price, and percentage of ownership for each unit that had a recent sale. One of the units listed is the subject unit. The memo indicates the subject PIN 1003 sold for \$130,000 in 2008. Based on his evidence, the board requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Board further finds the evidence in the record supports a reduction in the subject's assessment.

When overvaluation is claimed the appellant has the burden of proving the value of the property by a preponderance of the evidence. National City Bank of Michigan/Illinois v. Illinois Property Tax Appeal Board, 331 Ill.App.3d 1038 (3rd Dist. 2002); Winnebago County Board of Review v. Property Tax Appeal Board, 313 Ill.App.3d 179 (2nd Dist. 2000). Proof of market value may consist of an appraisal, a recent arm's length sale of the subject property, recent sales of comparable properties, or recent construction costs of the subject property. 86 Ill.Admin.Code 1910.65(c). Having considered the evidence presented, the PTAB concludes that the evidence indicates a reduction is warranted.

The PTAB finds the best evidence of market value is the sale of the subject in April 2009 for \$130,000. The appellant and the board of review submitted evidence indicating the subject unit recently sold for \$130,000. The subject's assessment reflects a market value greater than the purchase price.

Based on this record the Property Tax Appeal Board finds that the subject property had a market value of \$130,000 for the 2010 assessment year. Since market value has been determined, the 2010 three year median level of assessment for class 2 property as established by the Illinois department of Revenue of 8.94% shall apply and a reduction is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
