Lake County Board of Review was notified of the above filing on 7-30-10. A total of 180 days has been granted for the submission of evidence. The BOR is requesting an additional 60 days to submit evidence. Request states that the BOR and the appellant's attorney are in the process of finalizing an agreement in the case and request the additional time to resolve the settlement.

- d. McDaniels Square Condo Assoc.: #08-04957-R-3 (Lake)

Lake County Board of Review was notified of the above filing on 11-23-10. A total of 90 days has been granted for the submission of evidence. The BOR is requesting an additional 30 days to submit evidence. Request states that the BOR and the appellant's attorney are in the process of negotiating a possible settlement of the case.

- e. Dolton LLC: #08-29251-I-2 (Cook – Thornton)

Intervenor, Thornton THSD #205, originally filed with PTAB on 9-7-10. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 30 days to complete its review of the appellant's evidence and submit evidence and legal argument.

- f. MB BP Portfolio II, LLC: #08-25954-I-2 (Cook – Leyden)

Intervenor, Leyden HSD #212, originally filed with PTAB on 9-7-10. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 30 days to prepare valuation evidence and/or legal argument.

- g. The Missner Group: #08-27822-I-3 (Cook – Niles)

Intervenor, Niles THSD #219 originally filed with PTAB on 7-19-10. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 30 days to submit evidence and legal argument.

- h. Jack Gore: #08-28339-C-3 (Cook – Schaumburg)

Intervenors, Palatine THSD #211 and Schaumburg CCSD #54, originally filed with PTAB on 9-22-10. A total of 90 days has been granted for the submission of evidence. Each Intervenor is requesting an additional 30 days to complete review and submit evidence and legal argument.

- i. Kohl's Dept. Stores, Inc.: #08-06924-C-2 (Will)

Intervenor, Frankfort CCSD 157-C, originally filed with PTAB on 9-24-10. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 30 days to submit evidence and legal argument.

- j. Scott Retzloff & Assoc./Baker Hill: #08-03333-C-3 (DuPage)

Intervenor, Wheaton-Warrenville CUSD #200, originally filed with PTAB on 8-13-10. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 30 days to prepare valuation evidence and/or legal argument.

- k. Scott Retzloff & Assoc./Geneva Crossing: #08-03335-C-3 (DuPage)

Intervenor, Glenbard THSD #87, originally filed with PTAB on 8-13-10. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 30 days to submit evidence and legal argument.

- l. Countryside Healthcare Center LP: #08-02559-C-3 (Kane)

Intervenor, City of Aurora, originally filed with PTAB on 7-26-10. A total of 150 days has been granted for the submission of evidence. Intervenor is requesting an additional 60 days to file evidence. Request states that Intervenor has made repeated attempts to contact counsel for Countryside to inquire about intentions for proceeding with the remaining years under appeal and are awaiting a response. PTAB entered a final decision in February of 2008 for the 2004 Countryside appeal but years 2005, 2006, 2007, and 2008 remain open.

- m. Harris Bank: #08-25570-C-2 (Cook – Thornton)

Intervenor, S.D. #215, originally filed with PTAB on 4-5-10. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 60 days to submit documentary evidence or brief.

- n. Thornton Oil: #08-27535 (Cook – Orland)

Appellant originally filed with PTAB on 8-14-09 and an extension for further submission of evidence was requested. A total of 90 days has been granted for the submission of evidence. The latest extension expired on 5-4-10 with no response from the appellant. Evidence in the file was deemed insufficient and the appeal was dismissed on 9-27-10. Appellant is requesting appeal be reinstated. Request states that PTAB extension letter of 2-3-10 granting 90 days to appellant was not received by appellant and/or appellant's attorney. PTAB has no evidence of letter being returned for incorrect address and/or any reason. Appellant has submitted an appraisal along with the reinstatement request.

- o. Mary Roney: #08-22065-R-1 (Cook – New Trier)

Appellant originally filed with PTAB on 5-6-09. Filing included no evidence and appellant assessment request reads "To Be Sub." An extension request was not submitted. An Incomplete Letter (6-23-10) was mailed to the appellant with items checked by PTAB to be returned within 30 days or appeal would be dismissed. On 7-22-10 PTAB received another set of appeal forms from appellant with no appellant assessment requests completed and no evidence submitted. On 10-14-10, appellant submitted a "Revised" appeal form containing appellant assessment requests, a stipulation signed by appellant only, and grid (Section V) completed. Attached to the letter was a sheet containing numerous copies of "Return Receipts" with no explanation of significance. Appeal was dismissed on 11-30-10 for untimely filing. Appellant is requesting file be reinstated per 2-14-11 letter.

- p. Theodore Wynnychenko: #08-25053-R-1 (Cook – Northfield)

This appeal involves an owner occupied dwelling in which the taxpayer is challenging the assessment of the land. Taxpayer has requested the issuance of subpoenas for James Houlihan (now Joseph Berrios), Assessor of Cook County and Dana Reese, of Cook County's Assessor's Office. Appellant argues that the method used by the Cook County Assessor to establish the land assessment is arbitrary and unconstitutional. Furthermore the taxpayer has a 2007 appeal that is currently under administrative review. In the 2007 appeal, the PTAB affirmed the assessment. The Cook County Assessor has responded and has objected to the subpoena requests contending that they are unreasonable and request unspecified documents and data that are not necessary to estimate a value to the real property.

- q. TRG II LLC: #07-02807-I-3 (Kankakee)

Intervenor, Manteno CUSD #5, requests renewed Motion for Dismissal. Intervenor states that the Appellant has utterly disregarded no less than three PTAB Orders to produce documents relative to the sale of the subject property. That is:

- The October 21, 2009, PTAB Order granting the Intervenor's Motion for Formal Discover, and ordering the Appellant to produce the documents on or before November 20, 2009.
- The April 13, 2010, Subpoena Duces Tecum ("Subpoena"), requiring the Appellant to produce the documents on or before May 13, 2010.
- The July 29, 2010 PTAB Order granting the Appellant a "**final** twenty-one (21) days from the date of this letter (no later than August 16, 2010) to comply with the Order issued October 21, 2009 regarding the Subpoena Duces Tecum issued April 13, 2010."
