In each of the above appeals, Appellant filed with PTAB on 8-31-09. An extension of time was requested with each filing by the Appellant and PTAB has granted a total of 90 days to each Appellant. Appeals were dismissed on 11-15-10 for lack of evidence. Appellant claims (per 6-21-11 correspondence) that a reinstatement request was sent to PTAB on 11-23-10. A copy of this correspondence was included. The 11-23-10 correspondence requests that the dismissal orders be vacated and the above docket numbers be reinstated due to the fact that the extension requests granted by PTAB on or about 5-28-10 were not received.

On 4-28-11, S.D. #151 filed a Motion to Reinstate. Counsel asserts that he filed evidence on behalf of the school district but committed an embarrassing clerical error by failing to update the cover letter used to file evidence in the 2007 appeal.

The motion included a cover letter dated 6-10-10 that referenced the 2007 appeal (07-29655.001-005). The letter is stamped as being received by the PTAB on 11-17-10. The school district argued that despite carelessness, it complied with PTAB's instructions. It requested reinstatement.

The Appellant filed a motion objecting to the reinstatement asserting that the Intervenor's deadline for submitting evidence in this matter closed on 11-19-10 and the Intervenor's Motion comes more than 5 months after the PTAB's deadline to submit evidence. The Appellant asserts the Intervenor's Motion to Reinstate should be denied because the evidence is untimely.
