- bbb. Platinum Series LLC Wheaton: #11-02939-C-2 (DuPage)

Appellant originally filed with PTAB on 4-17-12. A total of 120-days has been granted for the submission of evidence with the latest being a **Final** extension expiring on 10-15-13. On 10-7-13, PTAB received a Motion to Substitute counsel for the Appellant. On 10-8-13, new counsel submitted an extension request for the completion and submission of an appraisal. Letter from appraiser includes a preliminary real estate analysis.

ccc. Ann & Charles Phillips: #11-00759-R-1 (Will)

Appellant originally filed with PTAB on 2-17-12. An initial review indicated evidence and a Final Notice from Will County Board of Review was missing from filing. A checklist and 30-day extension was mailed to the Appellant with a due date of 2-2-13. On 2-4-13, Appellant submitted a printout from the BOR stating a hearing was scheduled and Appellant failed to appear. Evidence supporting claim did not accompany this printout. Appeal was dismissed on 9-25-13 for lack of jurisdiction and evidence. Per correspondence received 9-28-13, Appellant submitted a completed grid analysis with comparable properties and requests the appeal be reinstated.

ddd. Himanshu LLC: #11-27231-I-1 (Cook – Lyons)

Appellant filed an appeal with PTAB on Thursday, 4-12-12 (postmark) from a Cook County Board of Review dated 3-12-12. The appeal filed with PTAB is one (1) day late. Appeal was dismissed on 9-4-13 for lack of jurisdiction. Per correspondence received 9-18-13, Appellant is requesting the PTAB reinstate the appeal stating it was signed and dated on 4-11-12, and placed in the U.S. Mail at that time.

eee. Jerry Santangelo: #11-01597-R-2 (DuPage)

Appellant filed with PTAB on 3-28-12. An initial review indicated an extension of time was requested for the filing of supporting evidence. A 90-day extension was granted to the Appellant with a due date of 4-2-13. Evidence was not submitted and the appeal was dismissed on 9-10-13. Per correspondence received 10-1-13, Appellant is requesting the appeal be reinstated due to an internal error misplacing the extension letter.

fff. Franca Bozzano: #11-32689-R-1 (Cook – Lyons)

Appellant filed with PTAB on 6-13-12 (postmark) from a 2011 Cook County Board of Review final decision dated, 2-24-12. An initial review indicated the appeal was filed past the deadline and subsequently dismissed on 10-7-13. Per correspondence received 10-17-13, Appellant is requesting a reinstatement and asks PTAB to consider a pending 2010 appeal (no decision yet).

kkk. Lumajo-Bolingbrook, LLC: #11-00195-C-2 (Will)

The above filing was deferred from the 10-8-13 Board Meeting.

The Will County Board of Review was notified of the above filing on 2-13-13. The BOR timely filed its evidence which included a copy of a stipulation dated December 1st & 2nd, 2011, signed by the Appellant's counsel, the DuPage Township Assessor and the Intervenor's attorney. The BOR issued its decision reducing the assessment to the stipulated amount stating the reason as a "Stipulation agreement between the Supervisor of Assessments/Township Assessor and the Appellant." In its submission the BOR requested the values on the stipulation signed and executed at the 2011 Board of Review level be sustained. Other than printouts from the Will County Real Estate Tax Inquiry Screen showing the execution of the stipulated values, no other evidence or extension requests were submitted by the BOR. The BOR's time to submit evidence expired on May 14, 2013.

Three taxing districts intervened (Bolingbrook Park Dist., Fountaindale Public Library Dist. & Valley View C.U.S.D. #365U), but were defaulted on August 28, 2013 due to the failure to submit evidence.

By letter dated September 3, 2013, the Will County BOR asserted it had joined with the Village of Bolingbrook and others to obtain an appraisal and requested a 30-day extension to submit the report. It asserted that in 2011 a stipulation was signed by the BOR and the Intervenor as a negotiated settlement and were of the opinion there would be no further action. However, according to the BOR, appellant's counsel has taken the position that the stipulation does not preclude him from pursuing further relief from the PTAB. The BOR requested that the PTAB give no weight to the stipulated document because there was no meeting of the minds due to the Appellant's interpretation of the stipulation not being the same as the BOR and Intervenor's.

The Appellant, through counsel, filed a letter objecting to the request of the Will County BOR for an extension of time to submit evidence. The Appellant asserted that the BOR's time for submission of evidence or request for an extension has expired pursuant to section 1910.40 of the rules of the PTAB.
