Letter from appraiser (2-14-15) references professional commitments as reason for a 60-day extension request.

Intervenor, C.U.S.D. #300, originally filed with the PTAB on 12-23-14. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension for the purpose of compiling evidence for the subject property.

Intervenor, J. Sterling Morton H.S.D. #201, originally filed with the PTAB on 11-26-14. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension for the completion of an appraisal. This property is a site that includes a ComEd transmission substation with several transformers. Real estate improvements include five industrial type buildings and site improvements such as chain-link fencing and asphalt pavement.

- w. Ricker Murphy Development: #13-25711-R-1 (Cook – Lake View)

In each of the appeals listed above, Appellant originally filed with the PTAB on 2-27-14. An unspecified extension request accompanied each appeal and the PTAB granted a 30-day extension on 10-15-14 for the submission of evidence with a due date of 11-14-14. This notification letter was mailed to the address provided for the attorney representing each appeal. A response was not received and each appeal was dismissed on 2-6-15. Per correspondence received 2-17-15, Appellant is requesting the appeals be reinstated and stating that the extension letter for each appeal was not received.

- x. Ricker Murphy Development: #13-25655-R-1 (Cook – Lake View)
Ricker Murphy Development: #13-25814-R-1 (Cook – Lake View)

In each of the appeals listed above, Appellant originally filed with the PTAB on 2-27-14. An unspecified extension request accompanied each appeal and the PTAB granted a 90-day extension on 9-25-14 for the submission of evidence with a due date of 12-24-14. This notification letter was mailed to the address provided for counsel representing each appeal. A response was not received and each appeal was dismissed on 2-6-15. Per correspondence received 2-17-15,

Appellant is requesting the appeals be reinstated and that the extension letter for each appeal was not received.

- y. Charles Besser: #12-33680-R-2 (Cook – N. Chicago)

Appellant originally filed with the PTAB on 5-14-13. An extension request of 90-days accompanied the filing by counsel representing the Appellant. A notification letter was mailed to address provided by counsel on 5-13-14 with a due date of 8-11-14. A response was not received and the appeal was dismissed on 2-2-15. Per correspondence received 2-27-15, Appellant is requesting the appeal be reinstated and that the extension letter was not received.

- z. G & Dee, LLC: #13-28269-R-1 (Cook – Proviso)

Appellant originally filed with the PTAB on 3-26-14. An initial review indicated information required to complete the filing was missing, including the original BOR decision. An incomplete checklist and notification letter was mailed on 10-16-14 with a 30-day extension due 11-15-14. On 11-12-14, Appellant returned some of the items on the checklist but did not submit the required Board of Review original decision and the appeal was dismissed on 1-16-15. Per correspondence received 2-19-15, Appellant believes they submitted all required information, including two copies of a PTAX (transfer declaration) from the Cook County Recorder of Deeds, and is requesting the PTAB reinstate the appeal.

- aa. Charles Phillips: #13-22591-R-1 (Cook – Lemont)

Appellant originally filed two separate appeals with the PTAB on 2-5-14 along with an extension request of 90-days to submit evidence. The notification letter and extension was granted on 8-26-14 with a due date of 11-24-14. Evidence and/or correspondence was not received on the above docket number and the appeal was dismissed on 2-6-15. Per correspondence received 3-20-15, Appellant is requesting the appeal be reinstated and that evidence timely submitted for his other appeal contained evidence for this appeal also. A copy of this evidence accompanied the reinstatement request. Evidence includes two sales.

- bb. Pima Lansing, LLC: #12-32217-C-1 (Cook – Thornton)

Appellant originally filed with the PTAB on 4-24-13 along with an extension request to file evidence. An initial review determined a 2012 Board of Review original decision was not included with filing, only a 2011 BOR decision. A 30-day extension and incomplete checklist indicating the requirement of a 2012 BOR decision was mailed on 4-25-14 with a due date of 5-25-14. Appellant received this information /extension and requested a second extension on 5-23-14 and then

a third extension on 8-18-14, with the latest being a final extension due 10-9-14. Sufficient evidence was received within the 10-9-14 deadline but the BOR 2012 original decision was never mailed to the PTAB as originally requested. The appeal was dismissed on 2-5-15. Per correspondence received 3-9-15, Appellant is requesting the PTAB reinstate the above appeal and included a BOR 2012 original decision. Request also states the Appellant was not aware of the need for a BOR 2012 decision until after the appeal was dismissed and a call was made to the PTAB.

cc. Thomas & Toni Richter: #10-04497-R-1 (St. Clair)

Appellant originally filed with the PTAB on 9-1-11 and elected to have an oral hearing. A proposed stipulation was offered by the St. Clair County Board of Review on 9-25-12, which the Appellant refused. The appeal was set for a hearing date of 2-23-15 and the notice was mailed to the Appellant on 12-3-14. The Appellant failed to show up for the hearing and the appeal was dismissed on 2-25-15. Per correspondence received 3-2-15, Appellant acknowledges that he failed to attend the hearing and requests the PTAB reconsider the decision and decide on the evidence presented in the file.

dd. Stahelin Properties: #12-03839-C-3 (DuPage)

Appellant originally filed with the PTAB on 4-18-13. The file was made Ready for Hearing on 1-20-15. The Appellant has filed a Motion to Stay Proceedings with the PTAB (received 2-19-15). Motion states the Intervenors, Board of Review, and the Taxpayer have agreed to a settlement pending the final assessments of years 2014, 2015, and 2016. As part of the settlement, a withdrawal request will be made for the 2010, 2011, and 2012 tax years.

ee. Metropolitan Bank Group: #13-20942-R-1 (Cook – Cicero)

Appellant originally filed an appeal and extension request with the PTAB on 1-2-14. A 60-day extension was granted to the Appellant on 8-25-14 with a due date of 10-24-14. Evidence and/or an extension request was not received and the appeal was dismissed for insufficient evidence on 2-6-15. Per correspondence received 2-18-15, Appellant is requesting the PTAB reinstate the appeal and indicated that an extension request was mailed to our office on 10-24-14. A copy of a dated 10-2-14 extension request referencing the above docket number is attached to the reinstatement and a certified mail receipt from the U.S. Postal Service for \$6.48.

- ff. Bridie Krystof: #12-23422-C-1 (Cook – Lake View)

Appellant originally filed with the PTAB on 2-6-13 for two parcel numbers and requested an extension of time to submit evidence. The PTAB granted a 60-day extension on 2-28-14 due 4-29-14. Appellant requested a 2nd extension and it was granted on 6-13-14 with a **Final** due date of 8-12-14. Appellant submitted evidence on 8-12-14 but did not supply the required addendum to include a breakdown for both parcels. The appeal was dismissed for this reason on 1-22-15. Per correspondence received 2-20-15, Appellant acknowledges the addendum was inadvertently omitted and included 3 copies of it with a reinstatement request.

- gg. Sauganash Village Homeowner's Assoc.: #12-33562-R-1 (Cook – Jefferson)

Appellant originally filed with the PTAB on 5-8-13. A total of 150-days has been granted for the submission of evidence with the latest being a **Final** and expiring on 7-14-14. Evidence to support the appeal was received on 7-14-14 but the required BOR original decision is not included for this parcel number. The Appellant submitted a copy of a BOR decision that doesn't include this parcel. The appeal was dismissed for this reason on 1-26-15.

- hh. Jim Riemersma: #13-24919-R-1 (Cook – Worth)

Appellant originally filed with the PTAB on 2-21-14. An initial review deemed the appeal insufficient and an incomplete checklist was sent with a 30-day extension on 10-3-14 with a due date of 11-2-14. Nothing was received from the Appellant and the appeal was dismissed on 1-12-15. Per correspondence received 3-9-15, Appellant is requesting the PTAB reinstate the appeal and included one set of evidence with no requested amounts. Appellant asserts that he did not receive the incomplete filing notice. Appellant submitted one copy of an assessment equity grid analysis with four comparables. Appellant failed to submit a completed appeal form with requested assessment amounts.

- ii. 9522 Winona LLC: #13-28729-I-3 (Cook – Leyden)

Appellant originally filed with the PTAB on 3-28-14 for two parcels. An initial review deemed the appeal insufficient and an incomplete checklist was sent with a 30-day extension on 10-24-14 with a due date of 11-23-14 (Sunday). On 11-24-14 (Monday), Appellant filed 3 copies of a 2013 appraisal, 2 copies of the BOR final decision for the 2013 year but did not return the required addendum to petition. Appeal was dismissed on 1-16-15 for this reason. Per correspondence received 2-20-15, Appellant requests the PTAB reinstate the appeal and also included additional copies of previously submitted evidence without an addendum.

jj. 2XL Corporation: #13-20991-I-1 (Cook – Proviso)

Appellant originally filed with the PTAB on 4-9-14. An initial review indicated several items missing from filing including a BOR original decision. An incomplete checklist granting a 30-day extension was mailed 11-6-14 with a due date of 12-6-14 (Saturday). Appellant, represented by counsel, submitted evidence on 12-8-14 (Monday) but did not include the required BOR decision. The PTAB dismissed the appeal for this reason on 2-9-15. Per correspondence received 2-19-15, Appellant is requesting the PTAB reinstate the appeal and believe they have satisfied all of the requirements. All previously submitted evidence accompanies this request.

kk. Oakridge Healthcare Center, LLC: #13-29618-C-3 (Cook – Proviso)

Appellant originally filed with the PTAB on 4-9-14. An initial review indicated several items missing from filing including a BOR original decision. An incomplete checklist granting a 30-day extension was mailed 10-30-14 with a due date of 11-29-14. Appellant, represented by counsel, submitted evidence on 11-26-14 but did not include the required BOR decision. The PTAB dismissed the appeal for this reason on 2-9-15. Per correspondence received 2-18-15, Appellant is requesting the PTAB reinstate the appeal and believe they have satisfied all of the requirements. All previously submitted evidence accompanies this request.

ll. Adnan Nassan: #12-29862-C-2 (Cook – W. Chicago)

Appellant originally filed with the PTAB on 4-12-13. An initial review indicated several items missing from filing including the Appellant's requested amounts for the two parcels being appealed. An incomplete checklist granting a 30-day extension was mailed 4-10-14 with a due date of 5-10-14. Appellant, represented by counsel, responded with a second extension request, which was granted. On 10-14-14 Appellant timely submitted evidence but did not provide an accurate breakdown of the assessment requests. The amounts requested by the Appellant are no different from what the parcels are currently being assessed at by the BOR. The PTAB dismissed the appeal for this reason on 2-5-15. Per correspondence received 2-24-15, Appellant is requesting the PTAB reinstate the appeal and believe they have satisfied all of the requirements. All previously submitted evidence accompanies this request.

mm. Bertha Garcia: #13-02472-C-3 (Kane)

Appellant originally filed with the PTAB on 3-11-14. An initial review indicated several items missing from filing including the Appellant's requested amounts, which were left blank. An incomplete checklist granting a 30-day extension was mailed 6-4-14 with a due date of 7-4-14. Appellant, represented by counsel, responded with a second extension request (7-3-14), which was granted as a **Final** extension due 9-16-14. No evidence was received and the appeal was dismissed on 12-30-14. Per correspondence received 2-20-15, Appellant indicates an extension request was mailed to the PTAB on 7-3-14 and a recent review of open PTAB matters indicated that this case had been dismissed. All PTAB correspondence, including dismissal, was addressed to counsel's address listed on appeal form and not returned for any reason.

nn. Tony Gutierrez: #13-26416-C-1 (Cook – Stickney)

Appellant originally filed with the PTAB on 3-7-14. An initial review indicated several items missing from filing including the Appellant's requested amounts with an addendum (multiple parcels) and the BOR original decision. An incomplete checklist granting a 30-day extension was mailed 10-2-14 with a due date of 11-1-14 (Saturday). Appellant timely responded on 11-3-14 (Monday) but did not include the required BOR original decision or the addendum with parcel breakdown requests. Appeal was dismissed for these reasons on 1-12-15. Per correspondence received 2-19-15, Appellant is requesting the PTAB reinstate the appeal and believe they have submitted all of the requirements along with resubmitting all.

oo. ML Realty Partners: #13-30701-I-3 (Cook – Proviso)

Appellant originally filed with the PTAB on 4-8-14. An initial review indicated several items missing from filing including the Appellant's requested amounts with an addendum (multiple parcels) and the BOR original decision. An incomplete checklist granting a 30-day extension was mailed 11-7-14 with a due date of 12-7-14 (Sunday). Appellant timely responded on 12-8-14 (Monday) but did not include the required addendum with parcel breakdown requests. The appeal was dismissed for this reason on 1-16-15. Appellant is requesting the PTAB reinstate the appeal and believe they have submitted all of the evidence.
