In each of the appeals listed above, Appellant originally filed with the PTAB on 5-1-15. A total of 90-days has been granted for the submission of evidence. Appellant is requesting an additional 30-day extension to prepare supporting documentation.

Appellant, represented by counsel, originally filed with the PTAB on 2-20-15. A total of 120-days has been granted for the submission of evidence with the latest expiring on 1-16-16. Intervenor is requesting an additional 60-day extension for the preparation of an appraisal. Letter from appraiser (2-8-16) indicates current work obligations as reason for additional time.

Intervenor, Summit S.D. #104, originally filed with the PTAB on 10-26-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension for the preparation of an appraisal. Letter from appraiser (2-4-16) indicates professional commitments as reason for request.

Appellant originally filed with the PTAB on 2-21-14. All evidence was submitted with the original filing and the Cook County Board of Review was notified of the appeal on 9-22-14 and granted a 90-day extension until 12-21-14 to submit evidence. Evidence including the required Notes on Appeal was received by the PTAB on 12-3-14 and the file was made Ready for Hearing on 12-17-14. On 8-27-15, a FOIA request was received from attorney group Robbins, Schwartz, Nicholas, Lifton & Taylor, Ltd. Requestor asked for all evidence submitted by the Appellant for this docket number. The requested information was copied and sent on 9-1-15. On 10-9-15, a Motion to Intervene Due to Failure to Receive Notice of Appeal from the BOR was received from the same attorney group representing possible Intervenor, N. Trier T.H.S.D. #203 and Glencoe S.D. #35. This Motion was forwarded to all parties to the appeal. On 10-29-15, Appellant, represented by counsel, responded to this Motion with a Response in Opposition

asking the PTAB to deny the Motion as untimely and further stating the Appellant sought a reduction less than the \$100,000 threshold that triggers BOR service of the petition on taxing districts, including proposed Intervenors.

v. Lisa & Phillip Adams: #11-33505-R-1 (Cook – Lake View)

Appellant, represented by counsel, originally filed with the PTAB on 6-19-15 for tax years 2010 and 2011 requesting a “Rollover” using a 2009 PTAB decision. The 2010 appeal was accepted and issued docket number 10-36215-R-1. The 2011 appeal was docketed and returned with a checklist indicating a “Rollover” applies to a subsequent year in the same general assessment period only. The 2011 appeal was subsequently dismissed for lack of jurisdiction on 1-8-16. Per correspondence received 2-10-16, Appellant is requesting the PTAB reinstate the 2011 appeal indicating the provisions of the statutes allow for an appeal in a subsequent tax year for the entirety of the 2009-2011 triennial reassessment period.

w. 9522 Winona LLC: #13-28729-I-3 (Cook – Leyden)

Appellant, represented by counsel, originally filed with the PTAB on 3-28-14 for two parcels. Appeal form was accompanied by an extension request to submit evidence. Appellant claim amounts were not completed for either parcel. An incomplete checklist with a 30-day extension was granted on 10-24-14 with a due date of 11-23-14 (Sunday) indicating the required sections to be completed. On 11-24-14, Appellant returned the checklist with an appraisal to submit as evidence. The required addendum with Appellant claim amounts was not completed as requested. The appeal was reviewed and dismissed on 1-16-15 for lack of required information. On 2-23-15, Appellant submitted a Request for Reinstatement of the appeal. This request went before our Board at its 4-14-15 meeting. The Board voted to reinstate the appeal and grant a 30-day final extension to submit completed addendum. The appeal was reinstated on 4-23-15 and a final 30-day extension was granted with a second checklist requesting the required breakdown for Appellant’s claim. No evidence and/or addendum was returned and the appeal was dismissed for a second time on 10-23-15. On 2-8-16, the PTAB received a Motion to Reconsider Dismissal from the Appellant with a correct breakdown of Appellant claim amounts included. Appellant acknowledges in the Motion that the 10-23-15 dismissal was from a missing addendum but further states the multi-parcel addendum was submitted with the original filing on 3-28-14.

In each of the appeals listed above, Appellant, represented by counsel, filed in February or March of 2015 and included a request for an extension of time to submit evidence. An initial review of each appeal indicated the required Appellant claim breakdown was not included. On 7-29-15, a return checklist with a 30-day extension was sent with a request for evidence and the required Appellant claim breakdown. On 8-28-15, each Appellant requested an additional 30-day extension. This request was granted on 9-3-15 with a 60-day extension and a due date of 11-2-15. On 11-2-15, Appellant requested another 30-day extension which was granted on 12-17-15 with a due date of 1-16-16. Evidence and Appellant breakdown claim was not received by the PTAB until 2-5-16. Appellant's counsel states the PTAB's latest granted extension (12-17-15 due 1-16-16) sent via e-mail went to spam because of a new network firewall with high-level security concerns from utility pipeline clients related to sensitive information of pipeline locations. Counsel further states the settings are modified on a frequent basis to tighten or release security standards and they are still in the process of finding the appropriate security and usability balance to protect client information. Appeals are due to be dismissed on 3-10-16 for insufficient evidence/untimely filing of evidence. Appellant is requesting the PTAB grant an extension and to accept evidence instantaneously.

- y. Jerzy Szymanski: #14-34130-C-1 (Cook – Lake)
Acme Truck Brake & Supply Co.: #14-34131-I-1 (Cook – Elk Grove)
JC Restoration: #14-34132-I-1 (Cook – Elk Grove)

In each of the appeals listed above, Appellant, represented by counsel, submitted 2014 new appeals to the PTAB on 2-4-16, more than 12 months late according to Board of Review Final Notices and 2014 Re-Review/Decision Dates for Cook County. Cover sheets on each state the appeals were previously submitted timely but were not processed by the PTAB. Each appeal has a Neopost Tracking Number printout attached indicating something was mailed from Chicago on 12-26-14 but no indication of ever being received by the Springfield U.S. Postal Service. Appellant believes the appeals to be timely filed and that they should be accepted. A search of the PTAB mail logs does not indicate a receipt from counsel.

- z. Ella Holdings, LLC: #14-34134-I-1 (Cook – Elk Grove)

Appellant, represented by counsel, submitted a 2014 new appeal to the PTAB on 2-4-16, more than 12 months late according to Board of Review Final Notice and 2014 Re-Review/Decision Date for Cook County. Cover sheet states the appeal was previously submitted timely but was not processed by the PTAB. Appeal has a Neopost Tracking Number printout attached indicating something was mailed from Chicago on 12-26-14 and delivered to Springfield on 12-31-14. PTAB mail logs do not indicate a delivery from this attorney's firm. Appellant believes the appeal to be timely filed and that it should be accepted.

- aa. Square D Company: #14-23452-I-3 (Cook – Palatine)

Intervenors, C.C.S.D. #15 and T.H.S.D. #211, originally filed with the PTAB on 9-1-15. A total of 120-days has been granted for the submission of evidence with the latest extension expiring on 1-3-16. A review of the file indicated no evidence/extension request was received and the Intervenors were defaulted on 1-21-16 and the file made Ready for Hearing. Per correspondence received 2-4-16, Intervenors are requesting the PTAB Reinstate Intervenor and Motion for Leave to File Evidence Instantly. A full appraisal was received by the PTAB on 2-8-16 (inadvertently left out of 2-4-16 mailing per cover sheet). Request states the counsel of record for the District went on maternity leave in the days following the extension request and internal miscommunication caused the missed deadline of 1-3-16. Request further states the tax years of 2013, 2014, and 2015 will most likely be grouped together for hearing purposes and as a result, the reinstatement will have no impact on the taxpayer at hearing.
