Intervenor states the appraiser was recently allowed to inspect the subject property on 2-26-16 and that a request for a complete copy of the lease agreement in place at the time of sale and a copy of the appraisal report prepared at the time of the April 2013 sale have gone completely ignored by the Appellant. The Intervenor requests the PTAB issue an order compelling the Appellant to produce within 28 days the lease agreement in place at the time of sale and the appraisal of the subject property completed at the time of sale.

The Appellant's attorney was copied on the above requests by the Intervenor. The Appellant's attorney responded to PTAB that a sale contract in connection with the April 2013 purchase of the subject property was not provided because the Appellant states that such a contract does not exist and a contract was not necessary because of the existence of the purchase option signed in 2011. Appellant also states that if an appraisal does exist it is not relevant to the value of the real estate because it will value the entire going-concern, including goodwill, personal property, and real estate. The Appellant is not in possession of such appraisal. Finally, the Appellant urges the PTAB to deny the Intervenor's request for an extension of time adding that the 180-day extension granted was more than enough time for the Intervenor to file its evidence in connection with this matter and further that the Intervenor has not demonstrated "good cause".

ii. Benita Levy: #12-34068-R-2 (Cook – North Chicago)

A hearing was set for the above Appellant on 11-12-15. The Appellant failed to show and the appeal was dismissed on 12-8-15. Per correspondence received 2-23-16, Appellant is requesting the PTAB reinstate the appeal stating the notice of hearing was not received. This was the 4th time the appeal had been rescheduled with the Appellant being either a "no show" or calling to reschedule on the morning of the hearing.

The Madison County Board of Review was notified of the above appeal on 4-8-15 and granted a 90-day extension to submit evidence with a due date of 7-7-15. On 7-7-15 (postmark) the BOR submitted its Notes on Appeal and a 90-day extension request. A Final extension was granted by the PTAB on 8-14-15 with a due date of 11-12-15 (Thursday). The BOR submitted its evidence on 11-23-15 with a postmark date of 11-13-15, one-day late. The appeal was made Ready for Hearing on 12-17-15. On 2-10-16, the Appellant's attorney filed with the PTAB a Motion to Reject the County's Evidence as Untimely. The Motion points out the postmark date of the BOR evidence received on 11-13-15 is one-day late and that it is unlikely to take 10 days to arrive at PTAB by mail.

Intervenor, Southwestern Illinois College #522, has adopted the evidence submitted by the Madison County BOR and believes the PTAB should accept the evidence, albeit on-day late and further states the appeal should be determined substantively on the merits rather than procedurally on the technical rules. The Intervenor believes the Appellant has suffered no prejudice as a result of the tardy submission of the BOR evidence in this case and that the PTAB should deny the Appellant's Motion.

The BOR believes the Appellant has suffered no prejudice as a result of the tardy submission of the BOR evidence and an oral hearing should be set.

The Appellant has responded to both the Intervenor and the Appellant by stating the BOR did not show good cause for the late submission and should be held in compliance with the PTAB's rules.

In each of the appeals listed above, the Appellant, represented by counsel, filed with the PTAB on 2-4-16 (postmark). The Boone County Board of Review decision had a date of 1-4-16. The due date for the appeals was 2-3-16 (Wednesday). The appeals were dismissed for untimely filing on 3-10-16. Per correspondence dated 3-14-16, Appellant's counsel acknowledges the one-day tardiness but requests the PTAB reinstate each appeal stating an internal misstep of his office using a 360-day financial calendar versus the 365-Gregorian calendar.

The Intervening Taxing Districts, New Trier Township High School Dist. 203 and Sunset Ridge Elementary School Dist. No. 29, filed a motion requesting the PTAB issue a Subpoena Duces Tecum for the production of an appraisal with the

valuation date of October 3, 2012 concluding an "as-is" appraised value of \$74,000,000 and a hypothetical "go dark" value of \$43,700,000.

The subject property was sold on January 16, 2013 for a price of \$72,250,000. This was a sales-leaseback transaction in which the buyer was W.P. Carey & Co. LLC and the seller was Kraft Foods. According to the information provided by the Intervenors an appraisal of the subject property was prepared in connection with this transaction with a valuation date of October 3, 2012, estimating the subject property had an "as-is" appraised value of \$74,000,000 and a hypothetical "go dark value of \$43,700,000.

Intervenors argue that the January 16, 2013 sale appears to be an arm's length transaction and is devoid of any conditions that would render the sale irrelevant or even unimportant. The Intervenors' review appraiser contends that the fact that a transaction was a sale-leaseback does not automatically imply that the sale was a non-market or above market transaction that should be disregarded. The Intervenors contend that their appraisers have indicated that the October 2012 appraisal is necessary to obtain information that is essential to derive and estimate of value of the subject property because an analysis of the appraisal would assist them in determining if the 2013 sale was made at arm's length and based on the subject's fair case value. Attached to the motion were three affidavits signed by appraisers Michael Marous, Niel Renzi and Eric Dost. Each affidavit states in paragraph 4:

“My main objective in seeking this document is to determine information related to the sale of the subject property that occurred in 2013. Specifically, the documents are necessary to obtain information essential to derive an estimate of value of the subject property because I need to determine if the 2013 sale was made at arm's length and if the sale price was based on the Subject's fair cash value.”

The Intervenors asserted that they have contacted the counsel for the taxpayer but have not been able to obtain a copy of the appraisal.

The Appellant responded to the motion, which included a statement and a copy of a letter dated February 10, 2016 directed to the Intervenors' counsel stating it does not possess the October 3, 2012 appraisal. The Appellant's counsel also argued the transaction took place after the 2010, 2011, 2012 and shortly after the 2013

assessment dates and is not relevant. Counsel also noted the filing periods for the 2010 through 2013 appeals have closed. Counsel also contends that the submission of the appraisal when the property later sold for a known amount is irrelevant.

The Appellant's counsel also noted that Section 1910.68 of the PTAB's rules provides in part that the request for the subpoena shall contain a statement that the subpoena, "is necessary to obtain information essential to derive an estimate of value of the real property under appeal. . . ." A review of the record disclosed that in each appraisal completed by Marous and Renzi (the Intervenor's appraisers) for 2010, 2011, 2012 and 2013, each noted the subject property was the subject matter of a sales-leaseback transaction and each appraiser was able to derive an estimate of value for the subject property for each of the years in question.

In response the Intervenor's counsel asserts that the request for the Subpoena Duces Tecum was directed not only to Kraft but to the purchaser, W.P. Carey.

mm. Sears Holdings Management Corp.: #13-26440-C-3 (Cook – Barrington)

Appellant originally filed with the PTAB on 3-7-14. The Cook County Board of Review was notified of the filing on 2-27-15. The BOR submitted its Certificate with a date of 4-13-15 inserted as the date all taxing districts were notified. C.U.S.D. #300 became an Intervenor, submitting evidence, and the file became Ready for Hearing on 12-17-15. On 2-28-16, C.U.S.D. #300 submitted to the PTAB Intervenor's Motion to Join Necessary Party. This Motion requests the PTAB to join the Village of Hoffman Estates as a necessary party to the appeal asserting the presence of this taxing body is necessary for the limited purpose of converting any taxes determined to have been overpaid into an interest bearing note due to the plaintiff as provided for in the Economic Development Area Tax Increment Allocation Act (20ILCS 620/4(g)(5)).
