Byron C.U.S.D. #226: #14-00462-I-3 (Ogle)

In each of the appeals listed above, Appellant originally filed with the PTAB on 3-4-14 and 2-18-15, respectively. The 2013 appeal has had a total of 420-days for the submission of evidence. The 2014 appeal has had a total of 270-days to supply evidence. Prior to the 2012 assessment year, the assessed value of Byron Station was subject to a court approved Section 9-45 of the Property Tax Code (35ILCS 200/9-45) settlement agreement. The hearings for the 2012 appeals filed by the owner Exelon and another filed by taxing district Byron C.U.S.D. #226 are currently scheduled by the PTAB and expected to last a total of 4 weeks. The documentary evidence filed by the parties in the 2012 appeals consist of over 16,000 pages of evidence contained in 27 binders. Due to the complexity of these matters, the voluminous evidence filing required, and the hearing, the Appellant requests an additional 90-day extension.

- b. Lawrence Aaron: #14-30808-C-1 (Cook – Hyde Park)

Appellant originally filed with the PTAB on 4-10-15. A total of 90-days has been granted for the submission of evidence. Appellant is requesting an additional 30-day extension to prepare supporting documentation.

- c. Professional Resource Development, Inc.: #15-00114-C-1 (Madison)

Appellant originally filed with the PTAB on 1-8-16. A total of 60-days has been granted for the submission of evidence. Appellant is requesting an additional 60-day extension to compile evidence and formulate legal arguments.

- d. Albino Cabera: #15-21211-C-1 (Cook – Berwyn)
Byline Bank: #15-21212-C-1 (Cook – Calumet)

In each of the appeals listed above, Appellant originally filed with the PTAB on 1-5-16. A total of 60-days has been granted for the submission of evidence. Appellant is requesting an additional 60-day extension to compile evidence and formulate legal arguments.

- e. Armstrong World Industries: #14-01974-I-3 (Kankakee)

The Kankakee Board of Review was notified of the above appeal on 1-8-16. A total of 90-days has been granted for the submission of evidence. The BOR is requesting an unspecified extension of time for filing additional evidence and an updated appraisal of the subject property.

- f. Johnson Controls Battery Group Inc.: #14-02328-C-3 (Kane)

The Kane County Board of Review was notified of the above appeal on 1-8-16. A total of 90-days has been granted for the submission of evidence. The BOR is requesting an additional 60-day extension to complete evidence.

- g. Medline Industries: #14-01446-I-3 (Lake)

The Lake County Board of Review was notified of the above appeal on 1-8-16. A total of 90-days has been granted for the submission of evidence. The BOR is requesting an additional 90-day extension for the completion of an appraisal.

- h. Macy's: #15-00031-C-3 (Madison)

The Madison County Board of Review was notified of the above appeal on 1-8-16. A total of 90-days has been granted for the submission of evidence. The BOR is requesting an additional 60-day extension to complete evidence filing.

- i. D.J.W., Ltd.: #14-00263-I-3 (Stark)

The Stark County Board of Review was notified of the above appeal on 9-24-15. A total of 150-days has been granted for the submission of evidence with the latest extension expiring on 3-15-16. On 4-15-16 (postmark), the BOR submitted a 60-day extension request (31-days late). The request states the BOR called the PTAB to inquire if a second extension request was received after the original 11-29-15 due date. The BOR was told that their extension request was received and being processed. The extension letter from the PTAB was mailed 1-15-16 with a due date of 3-15-16. The BOR states this letter was never received and requests a 60-day extension to meet with the property owner and try to stipulate on this appeal.

- j. C.C.S.D. #93: #14-03011-I-3 (DuPage)

Intervenor/Owner, Buckhead Ind. Properties Inc., originally filed with the PTAB on 11-16-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to complete, review, and submit evidence.

- k. Marquardt S.D. #15: #14-03000-I-2 (DuPage)

Intervenor/Owner, Cabot II-IL1 M05, LLC, originally filed with the PTAB on 11-16-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to complete, review, and submit evidence.

- l. Kohl's Illinois, Inc.: #14-02669-C-2 (Madison)

Intervenor, Alton C.U.S.D. 311, originally filed with the PTAB on 12-22-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension to pursue discussions if a settlement is possible in lieu of spending resources on formal appraisal services.

- m. Exelon Generation Company, LLC: #13-01185-I-3 (Ogle)

Intervenor, Byron C.U.S.D. #226, originally filed with the PTAB on 5-13-15. A total of 270-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension to file evidence due to the complexity of this nuclear power station. There are currently two pending appeals set for hearing before the PTAB beginning 4-11-16 and scheduled to last a total of 4 weeks with evidence consisting of over 16,000 pages contained in 27 binders.

- n. Delnor Community Health Care Foundation: #14-02203-C-3 (Kane)

Intervenor, Geneva C.U.S.D. #304, originally filed with the PTAB on 12-9-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension for the Appellant, the School District, and the Geneva Township Assessor to discuss a potential settlement of all pending appeals.

- o. Children's Habilitation Center: #14-30898-C-2 (Cook – Thornton)

Intervenor, West Harvey Dixmoor S.D. #147, originally filed with the PTAB on 12-10-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension for the completion of an appraisal.

- p. Carson Pirie Scott & Company: #14-31945-C-3 (Cook – Rich)

Intervenor, Elementary S.D. #159, originally filed with the PTAB on 12-23-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension for the completion of an appraisal. Letter from appraiser (3-29-16) indicates this is a 164,346 square foot, two-story, retail commercial building on an approximately 11.84-acres site and a 90-day extension is required to complete the assignment.

- q. Best Buy #311A: #14-23986-C-2 (Cook – Stickney)

Intervenor, Burbank S.D. #111, originally filed with the PTAB on 12-28-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension for the completion of an appraisal. Letter from appraiser (4-12-16) indicates professional commitments as reason for a requested 90-day extension to complete assignment.

- r. BASF Corporation: #14-02144-I-3 (Kankakee)

Intervenors, City of Kankakee and Kankakee S.D. #111, originally filed with the PTAB on 12-24-15. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 90-day extension for the completion of an appraisal. Letter from appraiser (4-1-16) indicates professional commitments as reason for a requested 90-days to complete assignment.

- s. Exelon Generation Company: #12-04331-I-3 (DeWitt)
Exelon Generation Company: #13-03247-I-3 (DeWitt)

In each of the above listed appeals, Intervenors, Clinton Unit S.D. #15, DeWitt County, Richland C.C.D. #537, and Vespasian Warner Public Library, originally filed with the PTAB on 8-26-15. A total of 180-days has been granted for the submission of evidence. Intervenors are requesting an additional 90-day extension for consultations with appraisers and experts regarding the need for an updated report for tax years 2012 and 2013. Property is the Clinton Nuclear Power Station.

- t. Brookdale Living Communities: #14-01997-C-2 (Kane)
Huntley Crossings Development, LLC: #14-02489-C-3 (Kane)
Huntley Crossings Development, LLC: #14-02492-C-2 (Kane)

In each of the appeals listed above, Intervenor, Huntley C.S.D. #158, originally filed with the PTAB on either 12-9-15 or 12-16-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to compile and submit evidence.

- u. South Holland Home, LLC: #14-29920-C-3 (Cook – Thornton)
The Villa at South Holland, LLC: #14-29934-C-2 (Cook – Thornton)

In each of the appeals listed above, Intervenor, S.D. #151, originally filed with the PTAB on 12-15-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension for the completion of an appraisal. Letter from appraiser (4-4-16) cites current workload as reason for request.

v. John Boedeker: #14-03532-C-3 (St. Clair)

Intervenor, Collinsville C.U.S.D. #10, originally filed with the PTAB on 10-14-15. A total of 135-days has been granted for the submission of evidence.

Intervenor is requesting an additional 45-day extension in order to access the property to perform an evaluation. Intervenor states previous requests to do so have been ignored.

Intervenor, Village of Fairmont City, originally filed with the PTAB on 10-15-15. A total of 135-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension for the completion of an appraisal. Request states that an appraiser as well as an environmental consultant have been retained and are attempting to schedule a time with the Appellant to inspect the property but numerous attempts have already been made with opposing counsel.

w. Mervyn Dukatt: #14-26882-C-2 (Cook – Leyden)
Fresenius Kabi USA: #14-27064-C-2 (Cook – Leyden)
KTR Capital Partners: #14-27182-I-2 (Cook – Leyden)

In each of the appeals listed above, Intervenor, Mannheim S.D. #83, originally filed with the PTAB on 11-16-15. A total of 120-days has been granted for the submission of evidence. Intervenor is requesting an additional unspecified extension for the completion of an appraisal.

x. Orland Holdings, LLC: #12-34243-C-3 (Cook – Orland)

Intervenors, Orland Fire Protection Dist., Orland Park Public Library, S.D. #135, S.D. #230, and Village of Orland Park, originally filed with the PTAB On 12-17-15. A total of 120-days has been granted for the submission of evidence.

Intervenors are requesting an additional unspecified extension to file evidence.

y. Ponds of Palos Townhouse Association: #14-26811-R-2 (Cook – Palos)

Intervenors, C.H.S.D. #230 and S.D. #118, originally filed with the PTAB on 11-16-15. A total of 120-days has been granted for the submission of evidence.

Intervenors request an additional 90-day extension for the completion of an appraisal. Letter from appraiser (4-12-16) indicates professional commitments as reason for request.

z. Highland Park CVS, LLC: #14-26751-C-2 (Cook – Palos)

Intervenors, C.H.S.D. #230 and Green Hills Public Library, originally filed with the PTAB on 11-16-15. A total of 120-days has been granted for the submission of evidence. Intervenors are requesting an additional unspecified extension for the completion of an appraisal.

aa. Kraft Foods, Inc.: #14-26010-C-3 (Cook – Northfield)

Intervenor, New Trier H.S.D. #203, originally filed with the PTAB on 9-22-15. A total of 180-days has been granted for the submission of evidence with the latest being a Final and expiring on 4-12-16. Intervenor is requesting an additional 90-day extension to file its final evidence and response to taxpayer's evidence. A partial submission of evidence has also been included. A subpoena duces tecum was approved and mailed to the Appellant after the PTAB's 4-12-16 board meeting for the production of an October 2012 appraisal.

bb. Donald Taylor: #13-01854-R-1 (Lake)

The Lake County Board of Review was notified of the appeal on 5-9-14 and granted a 90-day extension expiring on 8-7-14. On 8-6-14, the BOR responded by submitting Notes on Appeal and requesting a second 90-day extension. This request went before our Board and a Final Extension was granted on 8-29-14 and expiring on 11-27-14. No new evidence was submitted by the BOR. The appeal was made Ready for Hearing on 12-24-14. A decision was made based on the evidence in the file and was finalized and mailed on 3-18-16. Per correspondence received 4-13-16, The Lake County State's Attorney is requesting the PTAB amend our 3-18-16 decision and accept a signed stipulation between the BOR and the Appellant that is included with the correspondence. Request states this stipulation was mailed to the PTAB on 9-2-14 but we have no record of it.

cc. John & Jennifer Groh: #14-03424-R-1 (Lake)

The Lake County Board of Review was notified of the appeal on 6-18-15 and granted a 90-day extension expiring on 9-16-15. A response was not received and the BOR was found in default on 10-30-15 with the file being made Ready for Hearing on the same day. A decision was made based on the evidence in the file and was finalized and mailed on 3-18-16. Per correspondence received 4-13-16, The Lake County State's Attorney is requesting the PTAB amend our 3-18-16 decision. The request also states that it did submit its Notes on Appeal on 9-8-14 (please note the BOR was not notified of the filing until 6-18-15 and their evidence was not due until 9-16-15).

- dd. 401 N. Central Park, LLC: #11-26426-R-1 (Cook – West Chicago)

A decision was issued from the PTAB on 4-22-16 for the above docket number based on the evidence presented in the file. Per correspondence received 4-26-16, the Appellant has submitted a Motion to Vacate this decision. The Motion states the decision was premised entirely on the incorrect information that the subject property was purchased in June 2009 and that the correct year is actually 2006.

- ee. Ritzy's Café: #14-21566-C-2 (Cook – Elk Grove)

Appellant, represented by counsel, originally filed an appeal with 3 parcels with the PTAB on 12-24-14. The appeal was reviewed and several items were missing so it was returned with an incomplete checklist on 3-31-15 and granted a 30-day extension to return including sufficient copies, evidence, Board of Review original decision, and the Appellant's claim for land, improvement, and total on an addendum. On 4-30-15, Appellant submitted an extension request to submit documentary evidence. A 60-day extension was granted and due on 7-12-15. On 7-10-15, Appellant submitted its documentary evidence, a BOR original decision for the 3 parcels but no addendum or requested claim amounts. The appeal was dismissed on 12-17-15. Per correspondence received 3-25-16, Appellant's counsel is requesting the PTAB reinstate the appeal. The request states the information was timely filed on 7-10-15, providing tracking copies, and should be accepted. All information has been included again but an addendum to the petition has now been added with a breakdown for each parcel.

- ff. Glenn Moak: #10-25472-C-1 (Cook – New Trier)

A decision was written based on the evidence presented in the file for the above docket number on 2-19-16. Per correspondence received 4-19-16, Counsel representing the Appellant for the 2010 tax year states that new counsel was retained for subsequent tax years and the new counsel received a certificate of error for 2010 reducing the assessed value to \$82,876 but never informed the previous counsel. The PTAB's decision, issued after the C of E, resulted in the requested AV of \$132,500. As a result, the Cook County Treasurer issued a substantial back tax bill. Previous counsel is requesting the PTAB vacate the order and dismiss the appeal to eliminate the back tax and states the BOR does not oppose this request.

gg. River Park Place, LLC: #12-05141-R-3 (Kane)

A decision was approved and mailed by the PTAB on 11-20-15 for the above docket number containing 27 parcel numbers. Per correspondence received 3-30-16, Appellant requests the PTAB re-issue a new Final Administrative Decision for this docket number because the original decision was not received. Appellant also states that one of the parcel numbers on the decision is incorrect.

hh. Den Georgopoulos: #13-20264-C-1 (Cook – Palos)

Appellant originally filed with the PTAB on 12-13-13 using a real estate tax consultant. The consultant is not listed on the appeal because he is not an attorney and not authorized to represent a taxpayer. The appeal was set for hearing on 6-8-15 but the Appellant did not appear and the appeal was dismissed as a “No Show”. Appellant mistakenly thought the tax consultant he hired would be notified of any correspondence from the PTAB. Per correspondence received 5-2-16, counsel has been retained to represent the Appellant and is requesting the PTAB reinstate the appeal stating the consultant originally hired by the Appellant was not authorized to practice law, and manipulated and harmed the taxpayer.
