A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 60-day extension for the completion of an appraisal. Request further states the appraiser has not yet completed preparation of the evidence because of unforeseen circumstances. Letter from appraiser was not included.

Appellant originally filed with the PTAB on 2-3-14 from a 2009 PTAB Final Administrative Decision issued 1-24-14 reducing the total assessment to \$15,051. On 7-22-16, PTAB carried forward the assessment to the 2010 assessment year pursuant to the “rollover” provision of Section 16-185 of the Property Tax Code. Per correspondence received 7-28-16, the Kankakee County State’s Attorney’s Office has filed with the PTAB a Motion to Reconsider and Vacate Decision citing the subject property is not owner-occupied but rather a rental property, therefore, the “rollover” provision of Section 16-185 of the Code is not applicable.

David Richter: #11-33890-R-1 (Cook – New Trier)

In each of the appeals listed above, Appellant, represented by counsel, filed with the PTAB on 7-22-15 and 12-7-15, respectively. Final Administrative Decisions dated 6-24-16, were rendered for both appeals without an oral hearing. Per correspondence received 7-18-16, counsel is requesting the PTAB vacate its decisions and dismiss the appeals stating both were filed in error with the PTAB as rollover cases when the BOR had further reduced the assessment from the prior year. Counsel states there are no Intervenor and that the BOR has no objection to this request.

- w. Eli Lavie: #11-23612-R-1 (Cook – New Trier)
Eli Lavie: #12-26120-R-1 (Cook – New Trier)

In each of the appeals listed above, Appellant, represented by counsel, has submitted a Motion to Vacate Decisions issued 5-20-16 and 6-24-16. Motion states the PTAB failed to roll over the reduced 2010 assessment (first year of the New Trier assessment triennial) to the subsequent years of 2011 and 2012 thus over-assessing both years.

- x. David Rosen: #15-23412-R-2 (Cook – Lake View)

The Cook County Board of Review is requesting the Issuance of a Subpoena *Duces Tecum* and an Affidavit in Support of Issuance of Subpoena for the above docket number. Request states the Appellant has listed the subject property for sale on or about 6-20-16 with the instant list price of \$2,695,000 which the listing states is “below the appraisal price of \$2,825,000.” The BOR states the Appellant never presented nor referred to an appraisal valued at \$2,825,000 as part of its 2015 evidence before the BOR or PTAB but, rather, provided sales comparables of its own. Request further states the BOR does not know the date of this

additional, higher appraisal, nor does the BOR know the identity of the appraiser and obtaining this appraisal is essential to derive an estimate of value of the real property under appeal.

y. Par-A-Dice Gaming Corp.: #14-01111-C-3 (Tazewell)

Intervenor, City of East Peoria, timely filed with the PTAB on 1-4-16. A notification letter granting a standard 90-day extension was sent on 1-21-16 with a due date of 4-20-16. Evidence and/or an extension request was not received during this time frame and the Intervenor was defaulted on 6-24-16 and the file made Ready for Hearing. Per correspondence received 6-30-16, Intervenor filed a Motion to Vacate Default indicating that an appraiser was retained but Intervenor failed to submit an additional 30-day extension request to the PTAB beyond the 4-20-16 due date. A copy of this Motion was forwarded to the Appellant who provided a response on 7-6-16. The response states that the Intervenor does not mention or discuss Rule 1910.60(f) in its Motion to the Board regarding extensions for filing additional evidence such as **Without a written request for an extension, no evidence will be accepted after the Request to Intervene is filed.**
