Mr. Glorioso convened the meeting at 10:00 a.m. All members were present, Mr. Steffen arrived at 10:15 am.

- 2. Approval of Board Minutes from the August 9, 2016 Meeting:**

- 3. Adoption or Amendments to the Agenda:**

- 4. Executive Director's Report**

Mr. Apostol reviewed the agency's current operations and the Final FY16 Expense report. He reported PTAB fully cooperated with the GOMB in keeping agency expenses within budget and ended the year with a \$671,359 surplus. He also reported PTAB has expended only 7.2% of the FY17 approved budget through the first two months of the fiscal year.

Mr. Apostol reported budget negotiations with Labor Relations / AFSCME is still ongoing at this time. He stated he anticipates a final resolution of all issues will come in the next several months.

Mr. Apostol reported that recent staff additions, Albert Nguyen and Kelly McAuliffe, have been fully trained and are doing very well at the Des Plaines office. He also reported that he anticipates recruiting additional ALJs at both the Des Plaines and Springfield offices. He stated in the interim, PTAB will continue to utilize 75-day staff at both the Springfield and Des Plaines offices to assist in reducing the backlog of appeals.

Mr. Apostol reported on the progress of the DoIT program and other IT projects. He further reported (2) clerical staff are being recruited and will be assigned to scanning documents in advance of the On-Line filing initiative. He stated a further update will be presented to the Board in October and November in Springfield.

Mr. Apostol reported no Governor's Director's Cabinet meetings were scheduled in September. He further reported he participated in the "Council of Counsels" program on September 8th in Chicago and briefed the Board on some topics for discussion.

Mr. Apostol reported PTAB continues to be current with all Governor's Office of Citizen Action inquiries and FOIA requests at this time.

Mr. Apostol reported the Human Rights Commission has reviewed and approved PTAB's Affirmative Action Plan and is in compliance pursuant to Sections 2520.77(c) of the Department's Rules and Regulations.

Mr. Apostol reported the state audit is underway and both he and the Fiscal Officer, will meet with Sara Metzger, Audit Manager, from the Office of the Auditor General on September 28th in Springfield.

Mr. Apostol presented the Proposed 2017 PTAB Meeting Schedule for review and approval. After considering and proposing several amendments, Mr. Freeman moved for Approval. Mr. Steffen seconded the Motion and it carried 5-0.

Mr. Apostol presented and reviewed the August 31st Workload Report. As stated at other meetings, this report reflects open appeals at the beginning of the year, new appeals added during the year, appeals closed during the year and appeals pending at the end of the year. He reported ALJ staff produced 2,956 decisions in August that is an all time monthly high.

He again reported, staff continues to work toward reducing the backlog of appeals and is meeting with staff to review current systems in an effort to streamline the decision generating process.

The Board proposed a Staff Appreciation Day on Tuesday, December 13th immediately following the PTAB Meeting for both the Springfield and Des Plaines offices to be hosted by Mr. Apostol and Mr. Glorioso.

Mr. Apostol presented graphs prepared by IT that reflect, Weekly ASI Visits, Decisions Viewed Weekly, Weekly PTAB Website Visits, Board Portfolios Viewed Weekly, Letters Viewed Weekly, Board Decisions by Month and Xerox Pages printed Monthly. He noted both taxpayers and practitioners are utilizing the website more to track the progress of appeals and to download information. He stated this has saved significant staff time and reduced duplication expenses. He further stated this information will be presented at all future PTAB meetings.

7. Other Business

The Proposed 2017 PTAB Meeting Schedule was reviewed, amended and approved under the Executive Director's report.

8. Adjournment

Mr. Steffen moved to adjourn the meeting at 11:00 a.m. Mr. Bilotta seconded the Motion and it carried 5-0.
