This property consists of 32.6 acres improved with 2 one-story masonry constructed industrial buildings with approximately 4,000 square feet.

Letter from appraiser (6-5-17) indicates professional commitments as reason for a 90-day extension request to complete the assignment.

Intervenor, Bensenville Elementary S.D. #2, Bensenville Library District, Bensenville Park District, Fenton C.H.S.D. #100, and Village of Bensenville, originally filed with the PTAB on 2-23-17. A total of 90-days have been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to compile and submit evidence.

Intervenor, Village of Merrionette Park, originally filed with the PTAB on 1-9-17. A total of 90-days has been granted for the submission of evidence. The latest extension expired on 6-6-17 and the request was postmarked on 6-9-17. The tardiness is explained as a clerical error within the attorney's office. Counsel represents another Intervenor within this file that has a different deadline and counsel believed the deadlines were on the same day. Intervenor is requesting an additional 60-day extension for the completion of an appraisal.

In each of the appeals listed above, Appellant, represented by legal counsel, filed with the PTAB on 5-10-16 requesting a 90-day extension along with appeal forms. A 90-day extension was granted by the PTAB on 12-29-16 with a due date of 3-29-17 per request. The appeals were reviewed and dismissed on 6-8-17 for lack of evidence and no response to the 12-29-17 notification/extension letter. Per correspondence received 6-15-17, Appellant is requesting the PTAB reinstate the appeals stating the extension/notification letter was not received for the above appeals.

- y. Thomas Davis: #15-04490-R-1 (Lake)

The Appellant originally filed with the PTAB on 3-30-16 requesting a total assessment of \$63,611. The Lake County Board of Review was notified of the filing and granted 180-days total to submit evidence with the final extension due on 2-5-17. On 1-19-17 the BOR submitted its "Notes on Appeal" and evidence indicating a possible stipulation of \$96,090. This information was forwarded to the Appellant on 2-2-17 with a 30-day extension to inform the PTAB if the possible stipulation was not acceptable. A response was not received and a final decision was issued with this amount from the PTAB on 5-19-17. Per correspondence received 6-5-17, Appellant is requesting the PTAB reinstate the appeal indicating a response rejecting the stipulated amount was sent to the BOR and the BOR failed to forward this to the PTAB. If reinstated, Appellant requests a hearing to produce a counter offer.

z. Richard Longsworth: #14-01797-C-1 (Lake)

Appellant, represented by legal counsel Jerri K. Bush, originally filed with the PTAB on 2-23-15. Evidence was timely received from Appellant and the BOR and the appeal was made Ready for Hearing on 8-12-15. On 3-22-17 the PTAB received a Notice of Withdrawal from attorney Jerri K. Bush removing herself as counsel of record. A hearing notice for 4-18-17 was addressed and mailed to the Appellant of record. The Appellant did not show at the hearing and the appeal was dismissed. Per correspondence received 5-16-17, new counsel is representing the Appellant and requests the appeal be reinstated. Request states the Appellant was unaware that previous counsel had withdrawn and therefore did not attend the hearing.

aa. Vincent J. Incopero: 13-20088-R-1 (Cook – Cicero)

Appellant originally filed with the PTAB on 12-9-13. An initial review deemed the appeal incomplete and a 30-day extension and checklist was sent to the Appellant on 8-20-14. The appeal was returned incomplete a second time and another 30-day extension was granted. After evidence was received, the BOR was notified of the filing on 5-15-15 and submitted evidence. A hearing was held on 2-28-17 and a No Change decision rendered on 5-19-17. Per correspondence received 6-1-17, Appellant has submitted a Motion to Reinstate along with a 2016 appraisal of the subject property asking the PTAB to reconsider its decision.

bb. Hugo Brandsetter: #13-30024-R-2 (Cook – N. Chicago)

Appellant, represented by counsel, originally filed with the PTAB on 4-10-14. The BOR was notified and submitted evidence and an Intervenor (CBOE) became a party to the appeal. A Ready Hearing letter was sent to all parties on 7-28-15. A stipulation signed by the BOR and the Appellant was received on approximately 2-9-17 by the PTAB. A decision was drafted using this stipulation and signed by the Board. This decision was mailed on 5-19-17. Per a Motion received by the Intervenor's counsel on 6-9-17, Intervenor is requesting the PTAB Vacate the Final Administrative decision and set the appeal for hearing. Motion states the Intervenor was not contacted regarding the stipulation agreement between the Appellant and the BOR, therefore, the decision should be vacated, the appeal reinstated, and a hearing set.

Docket #14-03011-I-3 is scheduled for hearing on 8-16-17 and Docket #14-03004-I-3 is scheduled for hearing on 8-15-17. - dd. Setkia Memishovski: #13-24600-C-1 (Cook – Worth)

Deferred from 6-13-17 meeting (item “y”).

Appellant, represented by counsel, appealed for the 2013 tax year with the PTAB and received a decision on 1-27-17. Appellant’s counsel did not file a “Rollover” appeal for the 2014 tax year and the Appellant does not know if counsel attempted to contact her or not because she was going through a traumatic family experience. Counsel did, however, file with the Cook County Assessor’s office. Appellant requests leave to file a 2014 appeal with the PTAB even though the filing period expired on 2-26-17.

- ee. Ali Khounsary: #10-33717-C-1 (Cook – Thornton)

Appellant, represented by counsel, originally filed with the PTAB on 8-22-11. Evidence was received from both the Appellant and the Cook County Board of Review and the appeal was set for hearing on 10-1-15. On 9-30-15, Appellant’s counsel submitted a withdrawal request and the appeal was withdrawn on 10-27-15. Per correspondence received 5-19-17, counsel forwarded a request from the Appellant to reinstate the appeal. An attached written note from the Appellant states he recently discovered the appeal was dismissed due to a misunderstanding and he does wish to have a hearing at this time.

- ff. Sherry McAuliffe: #15-01602-R-1 (Jo Daviess)

Appellant originally filed with the PTAB on 3-11-16. The Jo Daviess Board of Review was notified of the appeal on 8-24-16 with a 90-day extension to submit evidence due on 11-22-16. The PTAB did not receive a response and the BOR was defaulted on 6-23-17. Per correspondence received 6-26-17, the BOR is requesting the PTAB vacate the default stating the information sent 8-24-16 never made it to their office.

- gg. John P. Glunz: #13-24496-R-1

Appellant, represented by counsel, originally filed with the PTAB on 2-24-14 and did not request a hearing. On 10-24-26, Appellant sent correspondence to the PTAB requesting a change in the status to “hearing requested” and the PTAB2000 was updated to reflect this. A “no change” decision was rendered by the PTAB on this appeal based on the evidence in the file and certified on 6-23-17. Per correspondence received 6-26-17, Appellant’s counsel is requesting the PTAB vacate this decision and set the appeal for hearing as requested.
