Jose Larios: #15-39159-C-1 (Cook – Jefferson)

In each of the appeals listed above, Appellant originally filed with the PTAB on 5-9-16 and 5-16-16, respectively. A total of 90-days has been granted for the submission of evidence. Appellant is requesting an additional 30-day extension to prepare supporting documentation.

- b. Alden Fox River Horizon LP: #15-01306-C-2 (Kane)

The Kane County Board of Review was notified of the above filing on 4-13-17. A total of 90-days has been granted for the submission of evidence. The BOR is requesting an additional unspecified extension to review and complete evidence to file. This property consists of low-income housing senior citizen facility.

- c. Modine Manufacturing Co.: #15-06387-I-3 (McHenry)

The McHenry County Board of Review was notified of the above filing on 4-13-17. A total of 90-days has been granted for the submission of evidence. The BOR is requesting an additional 30-day extension to prepare a stipulation to resolve this appeal.

- d. Colburn-Hull, LLC: #15-06705-C-2 (McLean)

The McLean County Board of Review was notified of the above filing on 3-30-17. A total of 90-days has been granted for the submission of evidence. The BOR is requesting an additional 60-day extension to submit evidence.

- e. Longacre Ponds, LLC: #15-02316-R-3 (St. Clair)  
Kingston Hotel Group, LLC: #15-06692-C-2 (St. Clair)

In each of the appeals listed above, the St. Clair County Board of Review was notified of filing on 4-13-17. A total of 90-days has been granted for the submission of evidence. The BOR is requesting an additional 60-day extension due to a very heavy workload and a small staff.

- f. Fresenius Kabi USA: #15-28430-C-2 (Cook – Leyden)

Intervenor, Leyden C.H.S.D. #212, originally filed with the PTAB on 3-30-17. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 30-day extension to prepare materials for filing.

- g. Sunrise Hospitality, Inc.: #11-34740-C-2 (Cook – Elk Grove)  
Dover Park Condo Assoc.: #12-35578-R-3 (Cook – Elk Grove)

In each of the appeals listed above, Intervenor, Elk Grove C.C.S.D. #59 and T.H.S.D. #214, originally filed with the PTAB on 3-30-17. A total of 90-days has been granted for the submission of evidence. Intervenor are requesting an additional 60-day extension to complete their review and prepare materials for filing.

- h. City of Rochelle: #15-02000-I-3 (Ogle)

Intervenor, Creston S.D. #161, originally filed with the PTAB on 3-28-17. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 30-day extension to file evidence and/or a brief.

- i. South Pointe Condo Assoc.: #15-34089-R-2 (Cook – Rich)

Intervenor, Elementary S.D. #159, originally filed with the PTAB on 4-26-17. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension for the completion of an appraisal. Letter from appraiser (7-10-17) indicates a 90-day extension is requested to complete an appraisal report on this irregularly shaped land parcel.

- j. D & D Lodging LLC: #15-06420-C-3 (St. Clair)

Intervenors, O'Fallon H.S.D. #203, Central S.D. #104, and Southwestern IL College, originally filed with the PTAB on 3-28-17. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 60-day extension to submit evidence.

- k. True Partners Consulting, LLC: #15-31954-C-3 (Cook – Schaumburg)

Intervenors, Palatine T.H.S.D. #211 and Schaumburg C.C.S.D. #54, originally filed with the PTAB on 4-19-17. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 60-day extension to prepare legal arguments and materials for filing.

- l. Imperial Realty Co.: #15-25611-C-3 (Cook – Palatine)

Intervenors, Palatine C.C.S.D. #15 and Palatine T.H.S.D. #211, originally filed with the PTAB on 4-19-17. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 60-day extension to prepare legal arguments and materials for filing.

- m. Michael Enzweiler: #15-34782-R-1 (Cook – W. Chicago)

Appellant, represented by counsel, originally filed with the PTAB on 4-28-16. A stipulation from the Cook County Board of Review lowering the assessment was received by the PTAB on 1-17-17 and forwarded to the Appellant's counsel on 2-2-17 with a deadline of 3-4-17 to reject if applicable. A rejection was not received and a decision was rendered using the stipulation amounts on 5-19-17. Per correspondence received 6-22-17, Appellant's counsel is requesting the PTAB vacate this decision stating a rejection was drafted and mailed with a date of 3-2-17. A copy of this correspondence dated 3-2-17 is included with the request.

- n. Douglas Gannet: #14-22105-R-1 (Cook – N. Trier)

Appellant, represented by counsel, originally filed with the PTAB on 1-2-15 selecting Assessment Equity as the basis of the appeal. Three comparable properties were listed as evidence. A No Change decision was rendered on 4-21-17 by the PTAB based on the evidence presented in the appeal. Per correspondence received 7-14-17, Appellant's counsel is requesting the decision be vacated stating it was not the intention to file with comparable properties. Counsel further states the property was purchased in 2012 but the PIN number was changed between tax years 2013 and 2014. If the PTAB vacates the decision a stipulation will be submitted once approved by Cook County Board of Review.

- o. Evergreen Place Decatur: #15-00225-C-3 (Macon)  
Evergreen Place Decatur: #15-00226-C-2 (Macon)

In each of the appeals listed above, Intervenor, Mt. Zion Unit S.D. #3, originally filed with the PTAB on 12-5-16. A total of 90-days was granted to submit evidence. Evidence and/or correspondence was not received and the Intervenor was defaulted in both appeals on 6-27-17. Per correspondence (via Email) received 7-24-17, Intervenor is requesting the PTAB rescind the defaults issued stating their intention was to adopt the evidence submitted by Macon County Board of Review and not submit any new evidence.

- p. David Itah: #11-28975-R-1 (Cook – W. Chicago)

Appellant, represented by counsel, originally filed with the PTAB on 5-1-12. A stipulation was agreed to between the Cook County Board of Review and counsel for the Appellant. A decision was issued on 1-27-17 with the agreed total AV amount of \$18,978. Per correspondence received 6-23-17, counsel has submitted a Motion to Vacate Final Administrative Decision. Motion states the Appellant hired a company to file a 2012 Assessment Appeal with the Cook County Assessor's Office and a Certificate of Error for the 2011 year based on a 100% vacancy due to the building being uninhabitable and renovation. This was approved by the Assessor's Office resulting in a reduction of the 2011 AV of \$6,518. The BOR was not aware of the C of E and neither was Appellant's counsel in the PTAB appeal. The issuance of the 1-27-17 PTAB decision increases the assessment.

- q. 6700 S. Clyde Condo Assoc.: #12-27042-R-1 (Cook – Hyde Park)

Appellant, represented by counsel, originally filed with the PTAB on 3-22-13. A stipulation was agreed to between the Cook County Board of Review and counsel for the Appellant. A decision was issued on 3-24-17 with the agreed total AV amount of \$50,445. Per correspondence, counsel has submitted a Motion for Amended Decision requesting the appeal be dismissed. Motion states a Certificate of Error was completed in 2012 by the Appellant, unbeknownst by counsel with an AV of \$11,194. The issuance of the 3-24-17 PTAB decision increases the assessment.

- r. Marie Mazzarelli: #12-21286-C-2 (Cook – Palos)

Appellant, represented by counsel, originally filed with the PTAB on 1-11-13. A stipulation was agreed to between the Cook County Board of Review and counsel of the Appellant. A decision was issued on 4-21-17 with the agreed total AV amount of \$36,490. Per correspondence, counsel has submitted a Motion for Amended Decision requesting the appeal be dismissed. Motion states a Certificate of Error was completed in 2012 by the Appellant, unbeknownst by counsel with an AV of \$5,147. The issuance of the 4-21-17 PTAB decision increases the assessment.

- s. Montrose Dev, LLC: #12-32620-C-1 (Cook – Jefferson)

Appellant, represented by counsel, originally filed with the PTAB on 4-26-13. A stipulation was agreed to between the Cook County Board of Review and counsel of the Appellant. A decision was issued on 4-21-17 with the agreed total AV amount of \$71,404. Per correspondence, counsel has submitted a Motion for Amended Decision requesting the appeal be dismissed. Motion states a Certificate of Error was completed in 2012 by the Appellant, unbeknownst by counsel with an AV of \$62,400. The issuance of the 4-21-17 PTAB decision increases the assessment.

- t. Setkia Memishovski: #13-24600-C-1 (Cook – Worth)

Deferred from 6-13-17 meeting (item “y”) and 7-11-17 meeting (item “dd”).

Appellant, represented by counsel, appealed for the 2013 tax year with the PTAB and received a decision on 1-27-17. Appellant’s counsel did not file a “Rollover” appeal for the 2014 tax year and the Appellant does not know if counsel attempted to contact her or not because she was going through a traumatic family experience. Counsel did, however, file with the Cook County Assessor’s office. Due to traumatic experience, Appellant requests leave to file a 2014 appeal with the PTAB.
