Appellants originally filed a Residential Appeal with the PTAB on 3-22-16. The Hearing Options blocks were both checked indicating a hearing was requested and also indicating the PTAB may write a decision based on the evidence. The Lake County Board of Review submitted sufficient evidence and did not request a hearing. The appeal was made Ready for Hearing on 12-15-16 and a No Change decision being issued, based on the evidence in the file, on 7-21-17. Per correspondence received 8-28-17, Appellants state that a hearing was requested and not held and, therefore, request the appeal be reinstated with a hearing date set.

ii. Tom Sizopoulos: #16-27059-C-2 (Cook – Palatine)

Appellant, represented by counsel, originally filed a Commercial Appeal with the PTAB on 2-3-17 along with an appraisal dated 1-1-14, which completed the filing. An extension request did not accompany the appeal. On 7-19-17, counsel submitted an “Amended” appeal form with a new appraisal dated 1-1-16 to replace the original filing.

- jj. Christine Michael: #16-27066-C-1 (Cook – Lakeview)

Appellant, represented by counsel, originally filed a Commercial Appeal with the PTAB on 2-3-17 along with an appraisal dated 1-1-13, which completed the filing. An extension request did not accompany the appeal. On 7-19-17, counsel submitted an “Amended” appeal form with a new appraisal dated 1-1-16 to replace the original filing.

- kk. James Jones: #15-34008-R-1 (Cook – W. Chicago)

Appellant originally filed with the PTAB on 4-26-16 requesting the PTAB write a decision based on the evidence in the file. Sufficient evidence was received from the Cook County Board of Review and the appeal was made Ready for Hearing on 6-1-17. Rebuttal evidence was not received from the BOR and not received from the Appellant until after the decision was drafted. A No Change decision was issued on 8-18-17. Per phone call received in Des Plaines on 8-22-17, Appellant is requesting the PTAB reinstate the appeal because rebuttal was submitted. A review of the file indicates rebuttal was received on 7-6-17 (postmark) but was due 7-1-17 and therefore not processed. An envelope was also included with the rebuttal with a sticker reading “Returned to Sender” and a date hand-written on it of 6-26-17 (appears to be altered) but no official stamp from the U.S. Post Office.

Appellant, represented by counsel, originally filed with the PTAB on 4-12-16. A total of 120-days was granted for the submission of evidence with the latest being a Final Extension approved by the Board and due on 4-16-17. A response/evidence was not received and the appeal was dismissed on 7-27-17 for insufficient evidence. Per correspondence received 8-7-17, Appellant is requesting the appeal be reinstated stating they did not receive notice of an incomplete appeal filing. Accompanying the request is a completed appeal form dated 8-2-17 and an appraisal report dated 1-1-16.

In each of the appeals listed above, Appellant, represented by counsel, originally filed with the PTAB in March, April, and May of 2014. Hearings were scheduled for all on 6-22-17. The Appellant and/or counsel failed to show and the appeals were dismissed on 6-27-17. Per correspondence received 7-31-17, Appellant is contesting the dismissal due to lack of proper service stating a written or e-mail notification of the 6-22-17 hearing was not received. The Appellant's counsel also raised an issue about the inconsistencies of PTAB's delivery of communications referring to paper deliveries via regular mail and e-mail delivery of correspondence. Each file does contain a paper copy of the hearing notice dated 4-20-17.

nn. Marquardt S.D. #15: #14-03001-I-2 (DuPage)

This was an undervaluation appeal filed by Marquardt S.D. #15. AMB Property II, LLC/Prologis II, LP, Taxpayer/Owner acting as Intervenor, and Marquardt S.D. #15, Appellant, filed a Joint Motion to Vacate the decision issued by the Property Tax Appeal Board in the above referenced appeal on 1-27-17, increasing the assessment from \$808,270 to \$1,391,530. Following the decision, AMB Property filed a complaint for administrative review in the Appellate Court of Illinois, Second Dist., (Case No. 2-17-0167). While the matter was pending before appellate court, AMB property and Marquardt S.D. #15 reached a settlement resolution. To effectuate the terms of the settlement resolution the appellate court granted the Agreed Motion to Remand to the Property Tax Appeal Board. AMB Property II, LLC/Prologis II, LP and Marquardt S.D. #15 request the PTAB vacate its decision issued on 1-27-17 and grant the request to withdraw the appeal and close the file.

The parties assert that the DuPage County BOR has no objection to the motion. (The PTAB forwarded a copy of the motion to the DuPage County BOR via e-mail on 8-31-17.)
