Motion to Stay

Appellants filed with the PTAB on January 10, 2018 and requested a 90-day extension to submit evidence. On April 5, 2018, the appellants were granted a 90-day extension to submit evidence with a due date of July 4, 2018. On June 26, 2018, the appellants requested an additional 90-day extension to file evidence. On August 15, 2018, the appellants were granted a Final 60-day extension to submit evidence with a due date of October 14, 2018. On September 13, 2018, counsel for the appellants requested that the PTAB Stay the Taxpayer-Appellants documentary evidence filing due date in the 2017 assessment appeals until resolution of the 2014, 2015, and 2016 assessment appeals currently pending at the PTAB; or in the alternative, request that the PTAB grant a 90-day extension of time in which to file documentation on both appeals. They are currently engaged in discussions with the Intervenor and have been told that a response is forthcoming.

There is a hearing set for Tax Years 2014 and 2015 on Thursday, November 13, 2018 in Springfield.

Motion to Vacate Default

Village of Rosemont requested to Intervene on March 8, 2018 and was granted a 90-day extension to submit evidence with a due date of June 6, 2018. On June 6, 2018, the Intervenor requested an additional 60-day extension to submit an appraisal. On July 12, 2018, the Intervenor was granted a 60-day extension to submit evidence with a due date of September 10, 2018. On September 13, 2018, the Intervenor was found in default for failure to submit evidence. On September 13, 2018, the Intervenor's attorneys, Storino, Ramello and Durkin moved the PTAB to vacate any default judgment and grant an additional 1-day extension of time to file evidence and ask the Village of Rosemont be allowed to adopt and incorporate any evidence filed by the Cook County Board of Review. Intervenor asserts it failed to submit evidence in this matter due to a clerical error in misfiling of the correspondence notifying the Intervenor of the required date for the filing of evidence.

Motion to Vacate Final Administrative Decision

- On April 11, 2016, Verros, Lafakis & Berkshire, P.C., at the direction of Appellant, filed a 2015 Residential Appeal with the PTAB on PINs 25-03-121-010-0000 and 25-03-121-011-0000, requesting a total reduction from \$23,810 to \$15,527 (a reduction on each PIN from \$11,905 to \$7,764 and \$7,763, respectively, per the filed Addendum to Petition).
- The Cook County Board of Review decision dated February 24, 2016 included only PIN 25-03-121-010-0000.
- A cover letter was included indicating the Appellant was in the process of obtaining an amended decision from the Cook County Board of Review with both PINs. An email was sent by the appellant to Allen Manuel of the Board of Review requesting an amended decision on April 4, 2016.
- On October 14, 2016, PTAB issued an Incomplete Appeal Checklist indicating that the Appellant must submit a BOR decision for PIN 25-03-121-011-0000.
- On November 7, 2016, the Appellant again sent an e-mail to Allen Manuel requesting an amended decision including PIN 25-03-121-011-0000.

- The appellant was unable to secure an amended decision and on November 14, 2016, filed an amended complaint for PIN 25-03-121-010-0000 only, requesting a reduction from \$11,905 to \$7,764.
- PIN 25-03-121-011-0000 was marked as VOID in correspondence from PTAB dated July 6, 2017.
- The case was decided on the evidence by PTAB and although the Final Administrative Decision indicates that the PTAB hereby finds a Reduction in the assessment of the property, the assessment of PIN 25-03-121-010-0000 had been increased from \$11,905 to \$22,231.
- Based on the initial filing including two (2) PINs with a total combined assessment of \$23,810, it appears that PTAB made its decision “reducing the assessment to \$22,231” based on the inclusion of the assessment relating to PIN 25-03-121-011-0000
- The Appellant, AN Capital, LLC, requests that the PTAB enter an order to vacate the 2015 Final Administrative Decision and the complaint be dismissed.

Request for Reinstatement

Appellant filed with the PTAB on December 20, 2017. The appellant submitted an appraisal in support of the overvaluation argument. On June 21, 2018, an incomplete extension was granted to submit the addendum to petition and the amounts for each parcel with a due date of July 21, 2018. On September 13, 2018, the appeal was dismissed for failure to submit an addendum. On September 17, 2018, the Appellant’s attorney sent in correspondence that he did receive an email in June, but the link was not attached to any documents. He did receive correspondence on September 17, 2018 that he was able to open but he did not open the Zip or PDF file on June 21, 2018. Appellant is asking for reinstatement of this appeal and for the Incomplete checklist that he did not receive in June.

cc. Lake County Board of Review

Motion for an Extension of Time to Submit Evidence

The Lake County Board of Review (LCBOR), by and through its attorneys, Michael G. Nerheim, Lake County State’s Attorney, and Matthew Fronk and Gunner Gunnarsson, Assistant State’s Attorneys, and pursuant to 86 ILAC §1910.40(d) of the PTAB Official Rules, submits this request for an extension of time to file its evidence on appeal.

The LCBOR asserts it has over 2,500 assessment appeals pending before the PTAB. The LCBOR is presently in the middle of conducting its annual Board of Review appeal hearing process related to 2018 valuations. To complicate matters, the County of Lake, including the Chief County Assessor's Office, is transitioning to a new property tax database platform, meaning the tools used in their old system will be going away in November 2018. The LCBOR does not anticipate the ability to be up and running with the new tax platform within the time allocated under PTAB's Rules for evidence submission. Therefore, the LCBOR is requesting PTAB grant a 180-day extension to submit evidence on all PTAB Appeals coming due in October through December 2018 (1,469 listed on addendum). The LCBOR request to appear before PTAB at its October 2018 meeting to provide additional details on this request and answer any questions from the Board.
