Appellant filed with the PTAB on April 24, 2018 (envelope postmark date). On September 13, 2018 the appeal was dismissed due to being untimely filed. On September 26, 2018, the Winkler Group, LLC legal counsel for the appellant requested the appeal be reinstated. Motion to Reinstate Taxing Bodies as Intervenors

Adlai E. Stevenson H.S.D. #125 and Aptakisic-Tripp C.C.S.D. #102 requested to Intervene on January 18, 2018. On Thursday, March 1, 2018 both Intervenors were granted a 90-day extension to submit evidence with a due date of Wednesday, May 30, 2018. On June 1, 2018 the PTAB received a letter dated May 30, 2018 from the Intervenors requesting an additional 90-day extension of time to analyze taxpayer's uniformity analysis and submit evidence, sent via UPS Next Day Air. The PTAB stamped the letter as being postmarked May 31, 2018, however, the UPS tracking has no date. On September 20, 2018, both Intervenors were found in default for failure to submit timely evidence/extension request. On September 27, 2018, attorney for both Intervenors filed a motion to reinstate taxing bodies. Intervenors' attorney attached a copy of the letter dated May 30, 2018 requesting a 90-day extension of time to submit evidence. Attached to the motion were two affidavits wherein counsel asserts that on May 30, 2018 he handed the extension letter to his legal assistant on May 30, 2018 and she confirmed to him that she mailed the letter on the same day. The legal assistant asserted in her affidavit that on May 30, 2018 she caused the extension letter to be sent to the PTAB via UPS.

In contacting UPS with the tracking label number, we were informed the extension letter could have been sent on either late May 30, 2018 or May 31, 2018. Attorney states Intervenor's failure to be reinstated would deny their right to present evidence supporting the 2016 assessment despite filing a timely request for extension of time by the PTAB's May 30, 2018 deadline.

Motion to Vacate PTAB decision.

On September 4, 2018, Klafter and Burke received notice from the Cook County Treasurer that the decision from PTAB would result in an increase of assessed value. Klafter & Burke immediately notified the Treasurer that there was an error and supplied the property's "print outs". It appears that a Certificate of Error was issued by the Cook County Assessor, however, even after a FOIA request, Klafter & Burke is not certain of the current assessment based upon a Certificate of Error. The Assessor's website simply states the Certificate of Error has been sent to the Assessor for further processing. In addition to the facts stated, the property owner, Seaway Bank has filed for Chapter 11 Bankruptcy. After discussing the issues with the Receiver, they have instructed Klafter and Burke to vacate the order as there are no funds to pay possible increased taxes.

Regarding the thirty-six (36) outstanding 2016 & 2017 PTAB appeals which have an original due date of October 10, 2018, the Lake County Board of Review requests that the PTAB grant an additional 120-day extension to complete its evidence submissions for these appeals.

gg. DuPage County Extensions

Due to the number of appeals received that have evidence all due at the same time, the fact that they are in the DuPage Board of Review Session for 2018 and in order for DuPage County Board of Review to make sure their tax bills get sent out on time, the DuPage County Board of Review is requesting a 90-day extension from the due dates of November 21, 2018 to February 19, 2019, (464 appeals listed on addendum) in order to submit their evidence for these appeals.
