#### Motion to Stay Proceedings

On Monday, October 15, 2018, the Appellant filed a voluntary petition for relief under chapter 11 of the United States Bankruptcy Code. The Notice of Bankruptcy Filing and Imposition of Automatic Stay was included. Due to the bankruptcy filing Neal, Gerber & Eisenberg, LLP does not currently represent the Appellant. However, this firm will be filing a petition in the bankruptcy proceeding to be reappointed for the Appellant. Until counsel is reappointed for the Appellant the PTAB is requested to stay any further proceedings with respect to the appeals. The Intervenors, CUSD #300 and Village of Hoffman Estates, have acknowledged their agreement with this request.

#### Motion for Amended Final Administrative Decision

Appellant, through his attorney Jeffrey G. Hertz, requests the PTAB amend the Final Administrative Decision for docket #13-25010. On January 1, 2018, the Appellant and the Cook County Board of Review agreed to a revised assessment for all involved PINs for assessment year 2013. On March 28, 2018, the Administrative Law Judge informed the Appellant's attorney and the Board of Review that there were incorrect assessed values on the stipulation. On March 29, 2018, counsel returned the corrected stipulation to the ALJ and the BOR. On May 15, 2018, the PTAB issued a Final Administrative Decision. However, the values on that decision were the original assessed values as finalized by the BOR; an Amended Final Administrative Decision was then issued. On September 19, 2018, counsel received notice from the Cook County Treasurer that two of the revised assessments in this matter resulted in assessment increases in the 2013 tax bills.

On May 24, 2018, the Appellant and the Cook County Board of Review agreed to a revised assessment for all involved PINs for assessment year 2014. On September 18, 2018, the PTAB issued its Final Administrative Decision in this matter.

The improvement assessment was incorrect on the stipulation sent to the Board for approval and was entered that way in the decision. This resulted in an increased assessment for the two parcels and the Treasurer has sent notifications of the resulting increase in real estate taxes. The correct improvement assessments for the two parcels should be \$6,483. This is the same improvement assessment as several other parcels with the same percentage of ownership and revised assessment. Counsel request that the PTAB issue an Amended Final Administrative Decision revising the improvement assessment for both PINs to \$6,483 and keeping the totals at \$7,407.

#### Motion to Revive Judgement

Taxpayers request the PTAB decisions be revived because the Cook County Treasurer's Office failed to issue refunds in these matters. In each of the above referenced appeals, the PTAB issued decisions reducing the assessments of the subject properties. As of this date the taxpayers contend they have not received the refunds based on the PTAB decisions. The taxpayers hired Kensington Research & Recovery, Inc. as their agent and granted their counsel authority to recover any overpayments of property taxes. Taxpayers request that the PTAB recognize Kensington's legal counsel, Natarajan/Worstell as their agent/attorney to revive judgements previously issued with respect to the property and recover any resulting property tax overpayments. The taxpayers request the PTAB issue orders reviving the judgement in each appeal so that the Cook County Treasurer's Office will issue a refund of the resulting overpayments.

Motion to Vacate the Final Administrative Decision and Withdraw Appeal

Appellant, by its counsel, Mar-Cal Law, P.C., filed the appeal based on a recent sale of the subject property. In October 2016, after the appeal was filed, Amari & Locallo merged with Mar-Cal Law. The appellant and the Cook County BOR reached a settlement establishing a total assessment of \$21,174 for the 2014 tax year. On November 14, 2018, the PTAB issued its decision in accordance with the settlement agreement. When the appeal was filed the appellant incorrectly listed the total assessment for the 2014 tax year, which was actually \$16,867. The PTAB's decision resulted in an increase in the 2014 assessment. By letter dated January 22, 2019, the taxpayer received notice from the Cook County Treasurer that the PTAB's decision resulted in an increase in the assessed value and an open item tax bill will be sent. The appellant requests the PTAB vacate the Final Administrative Decision and allow the appellant to withdraw the appeal.

Motion to Stay Proceedings

Appellant filed with the PTAB on February 28, 2018 and requested an additional 90-day extension of time to file evidence. On August 9, 2018, the appellant was granted a 90-day extension to submit evidence with a due date of November 7, 2018. On November 6, 2018, the appellant filed a Motion to Stay the appeal proceedings pending final resolution of the 2012 appeals.

The appeal involves the 2017 assessed valuation of Exelon's Byron Nuclear Power Station. Prior to the 2012 assessment year, the assessed value of Byron Station was subject to a court approved Section 9-45 settlement agreement. That agreement expired with the 2012 assessment year and both Exelon and the School District appealed the 2012 assessed value placed on Byron Station by the Ogle County Board of Review.

In the event the PTAB denies the School District's Motion to Stay Proceedings, due to the complexity of this matter, and the voluminous evidence filing required, the School District requests a 90-day extension of time to complete its evidence filings in the above captioned 2017 appeal.

**Motion to Re-Open Evidentiary Submission Period**

Appellant, William Corgan, by and through his attorneys, Steven B. Pearlman & Associates, requests that the PTAB grant Appellant’s Motion to Re-Open Evidentiary Submission Period for Docket #16-04611. (The appellant is actually requesting leave for a 30-day extension to submit a new appraisal.) Appellant filed with the PTAB on March 17, 2017 and requested a 90-day extension to prepare evidence. On October 12, 2017, the appellant was granted a 90-day extension to submit evidence with a due date of January 10, 2018. On January 10, 2018, the appellant requested an additional 60-day extension while awaiting additional evidence. On February 15, 2018, the appellant was granted a final 60-day extension to submit evidence with a due date of April 16, 2018. On April 16, 2018, the appellant submitted an amended complaint form with “Section V” completed

that included comparable sales as well as uniformity comparable properties; also included were property record cards, MLS listing sheets, comparable property grids and property tax assessment information printouts for the comparable properties used. Appellant did not submit an appraisal at the time of the April 16, 2018, submission. In the April 16, 2018 correspondence the appellant's counsel stated, "This completes Appellant's evidence submission for this 2016 Property Tax Appeal Board appeal." On September 6, 2018, the PTAB sent a letter to the appellant acknowledging that all information necessary to complete the appeal had been received and proceeded to notify the BOR of the appeal. The appellant is requesting leave to submit an appraisal within 30 days. The BOR has filed its evidence, which was postmarked November 16, 2018. The intervenor, Township HSD #113, has an extension until February 6, 2019. The appellant contends the request is not made for delaying the procedures, but to submit full and complete evidence on the subject matter on behalf of the appellant.

The Appellant did not submit an appraisal at the time of the August 3, 2018, evidence submission but is now requesting leave to submit an appraisal within 30 days. The BOR has filed its evidence, which was postmarked November 16, 2018. The intervenor, Township HSD #113, has an extension until February 6, 2019. The appellant contends the request is not made for delaying the procedures, but to submit full and complete evidence on the subject matter on behalf of the appellant.
