The Intervenor contends this appeal is premised on an undervaluation claim by the taxing body and involves a complicated fact pattern as well as an atypical set of claims by the Appellant, Intervenor and Board of Review.

DuPage H.S.D. #88 requested to Intervene on October 11, 2018 and was granted a 90-day extension to submit evidence with a due date of January 9, 2019. Batavia Public S.D. #101 requested to Intervene on November 8, 2018 and was granted a 90-day extension to submit evidence with a due date of February 6, 2019. Motion to Amend Decision

Appellant, Igor Blumin, by and through his attorneys, Golan Christie Taglia LLP, respectfully requests the PTAB amend its final administrative decision for Docket No. 14-28304. PTAB issued a no change decision on March 24, 2017 in the Appellant's appeal because it did not have a fully executed stipulation from the parties. The Appellant's 2014 appeal was one of many PTAB appeals, some involving multiple years, that Appellant's attorneys had settled prior to hearing with the Cook County Board of Review through one of its designated representatives. Appellant's 2014 appeal was part of the Jefferson Township triennial assessment (PTAB cases #12-30195, #13-28581, and #14-28304). The settlement document pertaining to the appeal was inadvertently not executed by the designated board of review representative pursuant to the agreement. The board of review representative realized the oversight and signed the document relating to the 2014 appeal and forwarded it to Appellant's attorneys for processing with the PTAB. All the parties agree that the correct 2014 assessment of the subject property should be:

Land: \$6,138, Improvement: \$30,122, Total: \$36,260

Appellant's attorneys request that the PTAB accept the agreement of the parties and issue an amended decision for the 2014 assessment year.

- oo. Brookdale Living Communities: #17-00304-C-2 (Kane)

Motion to Stay Proceedings

Appellant filed with the PTAB on January 25, 2018. The Kane County BOR was notified of the appeal on June 7, 2018 and was granted a 90-day extension to submit evidence with a due date of September 5, 2018. On September 5, 2018 the Kane County BOR requested an extension. On October 11, 2018 the Kane County BOR was granted a Final 60-day extension to submit evidence with a due date of December 10, 2018. On February 8, 2018 the County was found in default for failure to submit evidence.

Appellant, Brookdale Living Communities, by its counsel, Smith, Hemmesch, Burke & Kaczynski, moves the PTAB to stay its appeal for the 2017 tax year. The Appellant has drafted and executed a settlement agreement with the Rutland Township Assessor which resolves the outstanding PTAB matter for the 2017 tax year. The agreement contemplates the dismissal of the pending PTAB matter upon certification of values as agreed to in subsequent years. Upon certification of the 2019 assessment of the subject property by the Kane County BOR, the Appellant will move to dismiss its pending PTAB case for the 2017 tax year, docket #17-00304. The Appellant agrees to diligently review the assessment in subsequent years and will promptly move to dismiss the pending appeal pursuant to the time frames described herein, or the Appellant will promptly notify the PTAB if the stay should be removed. The Appellant respectfully requests that the PTAB stay all proceedings related to the 2017 appeal, including procedural and statutory evidence filing deadlines.

pp. Joe Castillo: #15-40258- R-1 (Cook-River Forest)

Motion to Vacate and Dismiss

Appellant, Joe Castillo, by and through his attorneys, Schmidt Salzman & Moran, Ltd., moves the PTAB to vacate its decision dated February 13, 2019 and to dismiss this appeal. Schmidt Salzman & Moran, Ltd. was retained to represent the Appellant for tax years 2014-2016. For tax year 2014, Schmidt Salzman & Moran, Ltd. obtained a decision from the PTAB reducing the assessed value from \$70,545 to \$66,416. For 2015, Schmidt Salzman & Moran, Ltd. filed the instant rollover appeal, which was assigned docket #15-40258. However, unbeknownst to Schmidt Salzman & Moran, the Appellant filed a pro se appeal for 2015 at the Cook County BOR, which reduced the 2015 assessment to \$64,206. PTAB's decision would result in an increase in assessment, this motion is brought within 30 days of the decision.

Subpoena Request

The appellant's counsel has requested the Property Tax Appeal Board issue a subpoena for the appearance of appraiser Andrew Norak and the production of documents in connection with the appraisal he prepared in the above matter set for hearing at the Board's office in Des Plaines on 4/4/19 at 9:00 AM.

rr. LeHigh Gas Corporation: #15-21490 (Cook-Palos)

Motion to Vacate Dismissal and Reinstate Appeal

On January 8, 2019, Administrative Law Judge Jennifer Vesely emailed a pre-hearing conference call indicating Docket #15-21490 was set for a pre-hearing conference on February 13, 2019 at 10:30 a.m. On January 10, 2019, Appellant Lehigh's counsel, John P. Sullivan, assigned the pre-hearing conference to his law partner, attorney James Dooley, who intended to appear on behalf of the Appellant. On February 9, 2019, four days before the scheduled pre-hearing conference, James Dooley fell and hit the back of his head on concrete, resulting in a head injury. He was taken via ambulance to NorthShore University Health System's Evanston Hospital, where he was admitted. (NorthShore University Health System Medical Records Excerpt, Exhibit C). James Dooley remained at Evanston Hospital from February 9, 2019, until he was discharged on February 11, 2019. Following testing, he was diagnosed with a concussion, subdural hematoma, and subarachnoid bleed. After being released from Evanston Hospital, because of his head injury and treatment plan, James Dooley did not work during the week of February 11, through February 15, 2019 and because of his condition, he did not contact John P. Sullivan, intervenors' counsel, or the PTAB to notify them of his head injury and that he could not attend the pre-hearing conference scheduled for February 13, 2019 at 10:30am. On February 21, 2019, Administrative Law Judge Vesely dismissed Appellant Lehigh's case, stating, "After considering the history of the appeal, the length of time the appeal has been pending and appellant's failure to appear at a PTAB settlement conference, the Board finds the appellant failed to pursue disposition of the appeal in a reasonable time and therefore, this matter is dismissed. Appellant Lehigh respectfully requests that the PTAB vacate the dismissal order and grant reinstatement so that the parties may pursue a resolution to this case.

- ss. Cook County BOR – Motion for Extension of Time. The Cook County Board of Review requests that the Property Tax Appeal Board allow an additional extension of time to file evidence on the following cases that have an April 3, 2019 deadline.

The Cook County BOR asserts it is grateful for the previously granted extensions however, due to the current workload, it is processing over 245,000 regular BOR appeals, which is another record-breaking year over last year's record high of 228,000.
