Motion to Vacate PTAB's Order of Default

The Lake County Board of Review (LCBOR) was notified of the appeals on July 19, 2018 and was granted a 90-day extension to submit evidence with a due date of October 17, 2018. Since no response was received by the deadline, the LCBOR was found in default on February 21, 2019. On March 19, 2019, the LCBOR by and through its attorneys, Michael G. Nerheim and his Assistants Matthew S. Fronk and Gunnar Gunnarsson of the Lake County State's Attorney Office requested the PTAB vacate its default order and allow the LCBOR to submit evidence for these appeals. Due to the volume of cases filed, the county assessment staff person responsible for opening the electronic notice from PTAB failed to add these

appeals to the LCBOR's electronic docket and the master list of appeals pending before the PTAB. As a result, staff members responsible for submitting evidence for the LCBOR in PTAB appeals, did not see these appeals listed and therefore did not submit the evidence by the deadline.

Motion to Vacate

On March 1, 2019, Richard Shapiro, appellant's counsel, received notice from the Cook County Treasurer that the decision from PTAB would result in an increase in the assessed value of the property. Unbeknownst to Counsel, his client filed a successful Certificate of Error with the Cook County Assessor for 2014. They have notified the Cook County Treasurer not to process this result.

hh. Preet Michelson: #15-25034-R-1 (Cook - New Trier)

Motion to reconsider

The PTAB issued a decision in the above matter on November 20, 2018, reducing the assessment of the subject property from \$244,862 to \$206,235, based on an agreement of the parties. The appellant was represented by Richard Shapiro. Prior to the PTAB settlement and without attorney Robert Shapiro's knowledge, his client, Preet Michelson, paid a recommended tax bill approved by the Cook County Assessor for a Certificate of Error based on an assessed value of \$179,493. Subsequently, the Cook County Board of Review voided the Certificate of Error because of the ongoing PTAB case. Counsel requests that since the assessor sets values and the PTAB settlement was for an assessed value of \$206,236, the PTAB honor the recommended assessed value by the Cook County Assessor of \$179,493.

ii. John Mengel: #01-23230-R-1 (Cook - New Trier)

Petition to Revive Final Orders

Movant, John Mengel, individually and on behalf of all taxpayers who obtained a final Order by the PTAB adjusting the value of the subject property more than 7 years ago and who have not received the resulting refund from the Cook County Treasurer's Office, by and through the law offices of Steven B. Pearlman & Associates, and Edelman, Combs, Lattuner & Goodwin, LLC, request that the PTAB grant Movant's Petition to Revive Final Orders. Plaintiff, John Mengel,

brings this Petition on his own behalf and in the representational capacity of all others that own or possess an interest in taxable real estate located in the County of Cook, State of Illinois, who obtained a final order in their favor by the PTAB adjusting the value of the subject property more than 7 years ago and who, as of this date, have not received the refund of the resulting property tax overpayment due to them by the Cook County Treasurer's Office. Counsel asserts that the Cook County Treasurer's Office has continuously refused to comply with 35 ILCS 200/23-20, P.A. 94-558, by failing to pay refunds from the next funds collected after final orders from the PTAB which would have resulted in tax refunds for taxpayers. Mengel requests the PTAB enter an Order calling for the "revival" of Mengel's Final Administrative Decision and all other PTAB decisions that were not paid out by any Treasurer in the State of Illinois.

The PTAB issued a decision in Docket No. 01-23230.001-R-1, on August 26, 2003, reducing the assessment on John Mengel's property, PIN 05-08-400-023-0000, from \$129,351 to \$99,460. The Cook County Treasurer's office has not issued a refund in accordance with the PTAB's decision.

By letter dated March 29, 2019, filed with the Property Tax Appeal Board, attorney at law Nora Ann Devine of Steven B. Pearlman & Associates requested to address the Board at its April meeting regarding the above-referenced case. The case pertains to a class action suit where taxpayers are not receiving property tax refunds due to them from the Cook County Treasurer.

jj. Michelle Eckroth: #15-31974-R-1 (Cook - Worth)

Motion to Vacate the Final Administrative Decision

Appellant, Michelle Eckroth, by and through her attorneys moves the Board to vacate the Final Administrative Decision and allow the withdrawal of this case. The decision agreed to by the parties and memorialized in a decision by the PTAB for 2015 inadvertently produced an increase in the assessed value. The decision issued by the PTAB was based on a stipulation by the parties.

kk. DSI Manteno Owner, LLC: #18-01146-C-3 (Kankakee)

Motion to Stay:

Appellant, Manteno S.D. #5, filed an undervaluation appeal with the PTAB on January 17, 2019, from a decision issued by the Kankakee County Board of Review on December 20, 2018, reducing the assessment from \$1,688,165 to \$810,620. The

appellant requests the PTAB stay the 2018 appeal until 90 days after the Appellate Court issues its mandate in the 2013 appeal of the subject property (13-00178), or in the alternative, grant the appellant a 90-day extension of time to submit evidence. On December 12, 2018, the PTAB entered an Order granting a stay of the 2014 (14-04151-C-3) and 2015 (15-06856-C-3) appeals of the subject property until 90-days after the Appellate Court issues its Mandate in the appeal concerning the 2013 appeal (13-00178-C-3).

II. Frank Venuti: #16-25820-R-1

Reinstatement Request

Appellant filed with the PTAB on January 24, 2017 and submitted an appraisal and assessment equity as evidence. The Cook County Board of Review timely responded to the appeal with evidence. On October 12, 2018, the hearing notification letter was sent to the appellant with a hearing date scheduled for December 19, 2018 at 11:00 A.M. By letter dated January 4, 2019, the appeal was dismissed for failure to appear at the hearing. On January 23, 2019, the appellant had a question about the hearing that she missed and the ALJ assigned to the case returned her call and left her 3 messages. Appellant returned the call to the ALJ on January 24, 2019, after work hours and stated she would return the call sometime the next week. On February 4, 2019, the ALJ again spoke with the appellant. The appellant thought PTAB was the assessor's office and that they filed on her behalf at PTAB, but the pleadings were submitted by her husband. Carmelina Venuti submitted a letter postmarked February 26, 2019, stating that she was caught off guard and did not realize the level the appeal had reached. She was sorry she missed the hearing on December 19, 2018, stating that she has never done this before and was unaware of the process. She would like her appeal to be reinstated to show the board that her home is being compared to much more elite homes in her area.

- mm. Cook County BOR – Motion for Extension of Time. The Cook County Board of Review requested that the Property Tax Appeal Board allow an additional 90-day extension to file evidence on the following cases that have a May 8, 2019 deadline.

The Cook County BOR asserts it is grateful for the previously granted extensions however, due to the current workload, it is processing over 245,000 regular BOR appeals, which is another record-breaking year over last year's record high of 228,000.
