A decision was issued by PTAB on March 19, 2019. The decision revised the subject property's assessment to \$244,664 from a BOR final assessment of \$263,009. After the decision was issued, the Cook County Treasurer notified the Appellant that a Certificate of Error had previously been issued for the 2016 tax year pending BOR approval. The 2016 Certificate of Error resulted in a revised assessment of \$176,927. A bill for 2016 taxes owed will be generated by the Cook County Treasurer due to the conflicting Certificate of Error and PTAB's decision. Appellant was unaware that the Certificate of Error had been issued until contacted by the Cook County Treasurer after the PTAB's decision. The appellant requests the PTAB vacate its decision and dismiss the appeal.

Reinstatement Request:

Appellant's attorney request to reinstate this appeal due to a failure to appear at the April 22, 2019 hearing, they inadvertently confused this docket number with another appeal they were withdrawing. The property consists of a one-story with basement retail/restaurant building with 1,354 square feet of building area constructed in 1958 located on a 15,179 square foot site. The appellant submitted

an appraisal estimating the property has a market value of \$205,000 as if January 1, 2015. The board of review has the property assessed at \$103,970 reflecting a market value of approximately \$311,910.
