Motion to Reinstate

Appellants by their attorney respectfully requests the PTAB to reinstate the above-referenced appeals. Appellants' counsel asserted the 2018 complaint forms filed with St. Clair County Board of Review lists the owner's mailing address as: 176 Auto Court, O'Fallon, Illinois 62269.¹

The Notice of Final Decisions of Assessed Value issued by St. Clair County Board of Review were dated February 1, 2019. Pursuant to Section 16-160 of the Property Tax Code (35 ILCS 200/16-160) a taxpayer may appeal the County determination to the Property Tax Appeal Board "within 30 days after the date of written notice of the decision of the board of review." Appellants' counsel contends it is "unclear" from the statute whether "the date of written notice" means the date written notice was received by the taxpayer or the date set forth on the written decision." Appellants' attorney argued if "the date of written notice of the decision of the board of review is interpreted to mean the date as set forth on the written decision, then pursuant to Section 1910.25 Illinois Administrative Code (86 Ill. Admin. Code §1910.25) the Appellants' "Commercial Appeal" to the Property Tax Appeal Board would have to be postmarked on or before March 4, 2019. The Commercial Appeals (forms) to the Property Tax Appeal Board were dated and signed on 2/28/2019, appear to be postmarked on March 5, 2019, one day late. For this reason, the Property Tax Appeal Board found the appeals were not timely filed. Appellants request the Property Tax Appeal Board allow the appeals that were postmarked March 5, 2019, to be considered timely filed claiming if the appeals are allowed to proceed, no one will be prejudiced. Counsel next asserted that if the 30-day period is interpreted to begin when Appellants received the written notice, then Appellants' apparent filings post-marked March 5, 2019, would be considered timely. Finally, Appellants appeal to the Property Tax Appeal Board on fairness grounds. Appellants' attorney argued that the St. Clair County Board of Review did not mail its Final Decision(s) on Assessed Value to Appellants' O'Fallon, Illinois address (purportedly listed on the 2018 Property Assessment Complaint

Forms to the St. Clair County Board of Review) or to Appellants' attorney.² Instead the St. Clair Board of Review mailed notices to McLean, Virginia, causing a substantial delay in receiving the actual written notices. Counsel argued it would be unfair to require the Commercial Appeals to be filed by March 4, 2019, deadline because of this additional reason. Therefore, the Appellants respectfully request the Property Tax Appeal Board, based upon fairness, to consider Appellants' Commercial Appeals timely filed

Reinstatement Request

Appellant filed the appeal depicting a postmark date of June 21, 2019 from a favorable Property Tax Appeal Board decision dated May 21, 2019. The appellant asserted the postmark date on the envelope was dated June 5, 2019, instead of the date of the final administrative decision dated May 21, 2019. The appellant believed the appeal was timely filed within the 30 days allowed by statute and is requesting the appeal be reinstated.
