School Dist. No. 212 intervened on June 20, 2019 and was granted a 90-day extension with a due date of January 1, 2020. On September 26, 2019, the Intervenor requested an additional 90-day extension to complete the rebuttal to the taxpayers' evidence.

Proviso Twp. H.S.D. #209 and Berkeley S.D. #87 requested to Intervene on July 11, 2019 and was granted a 90-day extension to submit evidence with a due date of October 9, 2019. On October 8, 2019, the Intervenor requested an additional 90-day extension to complete an appraisal report. The intervenors submitted a letter from the appraiser explaining that due to his professional obligations and current workload the appraiser requires a 90-day extension to complete the appraisal.

ss. Jagaria Jignesh: #17-33192-C-2 (Cook - Worth)

Cook County S.D. #130 requested to Intervene on June 20, 2019 and was granted a 90-day extension to submit evidence with a due date of September 18, 2019. On September 16, 2019, the Intervenor requested an additional 90-day extension to file evidence. The intervenor explained it has sent the appellant's appraisal to Dost Valuation Group, Ltd. For review and a preliminary opinion of value.

Reinstatement Request:

Appellants filed with the PTAB on Sunday, April 21, 2019, two days late from the Board of Review deadline of Friday, April 19, 2019 (Good Friday). The BOR decision was dated March 20, 2019. On Thursday, September 12, 2019, the appeal was dismissed for being untimely filed. On Wednesday, September 25, 2019, the appellant requested to reinstate the appeal asserting that on Saturday, April 20, 2019, she awoke with foot pain and was unable to walk or drive (that was already one-day late.) She is 88 years old and lives alone. Knowing that it was a holiday weekend and the post office was closed, she gave her envelope to one of her children to mail when they visited on Easter Sunday, April 21, 2019.

- ww. 1301 W. 138th LLC: #17-40223-I-2 (Cook - Thornton)

Motion to Correct the Record:

Appellant, by and through its attorney, moves the Honorable Board to allow the correction of evidence submitted with appeal. On September 16, 2019, counsel received notice from Intervenor, S.D. #205, that the appraisal attached to the petition was for another property.

PTAB's file disclosed the appeal was filed (postmarked) on May 25, 2018. The first page of the appeal references PIN 29-05-100-020-0000 with an Addendum for PINs 100-028/029/030 & 039-0000, which match the BOR decision and the appellant's brief. However, the appraisal submitted references PIN 29-29-100-010 and not the PINs on the appeal form or the BOR decision. The PTAB did not catch this error and processed the appeal as complete when in fact it should have been returned as incomplete.

The appellant's counsel contends that when the evidence was filed the appraisal sent from their office was for the correct property. The copy of their file have the proper appraisal with the petition. Counsel explained that when PTAB filings are made, several appeals are placed together in one USPS Priority Mail Box. The PTAB's notice of filing, dated December 6, 2018, was received in their office December 12, 2018, the letter did not indicate there was an issue with the appraisal. The PTAB sent notice to the Cook County BOR on November 26, 2018. On June 18, 2019, notes from the County were received. Nothing in the notes indicated that there was an issue with the appraisal. Only upon Intervenor's letter of September 16, 2019, was anyone made aware of the issue of the wrong appraisal attached to the appeal. Counsel asserts the correct appraisal was mailed with the correct Petition and Industrial Appeal form and request the evidence on record be amended to include the proper appraisal.

xx. 2737 W. Fulton LLC: #17-32120-C-1 (Cook - West Chicago)

Motion to Reinstate Appeal:

Appellant, by and through its attorney, moves the PTAB to reinstate Docket #17-32120 that was originally dismissed on December 27, 2018, due to an incomplete appeal being filed by Appellant for failure to include an addendum to petition. Appellant's Attorney asserted he did not receive notification from the Board's Clerk of either the August 16, 2018, email that the appeal was incomplete or the January 3, 2019, email notice that the case was dismissed. Attorney discovered that it had not been receiving other occasional correspondence emails from the Board due to the messages being sent to old email addresses that were no longer being used. Appellant's attorney has had two other instances of not receiving

correspondence and believed to have correctly addressed these errors by notifying the ALJ assigned to a hearing notice that was not received on May 9, 2019 and by notifying Mr. Louis Apostol of these notification failures January 21, 2016. According to the IT Department, the August 16, 2018, email notifying the Appellant of the incomplete appeal was successfully sent to 'flo@michaeldgertnerltd.com'. The email was never opened or downloaded, as this was an old email account that was no longer regularly being utilized by the Attorney's Paralegal. According to the IT Department, the January 3, 2019, case dismissal email was successfully sent and opened. It is the Appellant's Attorney's belief that the link was never downloaded, as Attorney was not actually made aware of the dismissal until October 2, 2019. Finally, Docket #17-32120 was originally filed under the firm, 'Gertner & Gertner, Ltd.', on March 13, 2019, with a contact email address listed on the appeal as, 'GertnerLawLtd@Ameritech.net'. However, the email address that the Clerk sent correspondence to 'flo@michaeldgertnerltd.com', was a former email address used prior to 2014, when the firm was known as 'Michael D. Gertner, Ltd.'. The email address listed on the original appeal never received notification of either the August 6, 2018, incomplete appeal or the January 3, 2019, notice of case dismissal.

- yy. Madhu Patel: #14-31516-R-1 (Cook)
Madhu Patel: #16-42474-R-1 (Cook)

Motion to Vacate Decision & Reopen Appeals:

Appellant filed appeals for 2014 and 2016 with the PTAB. At the time of filing the home was assessed as having 4,066 sq. ft. The PTAB confirmed the assessments for 2014 by decision dated 6/23/17 and for 2016 by decision issued on 1/15/19. Each decisions describes the subject property as have a dwelling with 4,066 square feet of living area. A review of both petitions disclosed the appellant described the subject dwelling as having 4,066 square feet of living area. In the meantime, appellant filed an appeal for square footage correction with Cook County Assessor's office and received a letter from Cook County Treasurer's office regarding a Certificate of Error Over-Assessment Refund application for 2013 & 2015. Appellant also filed Certificate of Errors with Cook County Assessor for refund based on the corrected size of 3,790 square feet. The refund for 2014 was approved and then it was voided in 2019 due to PTAB's determination on the 4,066 square footage. This is the last year to file a Certificate of Error for 2016, appellant is requesting PTAB vacate the decisions and re-open to get the refunds they are entitled to.

- zz. Motion to Reconsider Denial of Extension, Vacate Defaults and Extend Deadline to Submit Evidence.

Lake County BOR, by and through its attorneys, request the Honorable Board Vacate Defaults made in 391 outstanding PTAB appeals and grant its request for 120-day extension to submit evidence. An unknown error, either operator or computer, resulted in the query failing to show these 391 appeals with the September 4, 2019, deadline. On or about September 10, 2019, LCBOR located this error. By letter dated October 9, 2019, PTAB advised LCBOR that its extension request was untimely and denied LCBOR any further extensions to submit evidence. County notes Administrative Code: 1910.40(a) that provides for an extension with good cause shown and asserts that this section does not state the board of review must submit the letter requesting an extension of time before the deadline. LCBOR tracks a large quantity of appeals and utilizes a procedure in which a query generates a list of pending appeals and the correlating deadlines. Due to an unknown error, the query failed to include the deadlines for the 391 appeals. The day after this error was identified, LCBOR attempted to correct the error by requesting an extension. PTAB's denial would cause LCBOR to be barred from presenting evidence in these appeals, which would likely lead to all 391 appeals being upheld. Refunds by all involved taxing districts, including school districts, would be required. Allowing LCBOR to request an extension merely one week after the deadline would not prejudice the appellants from submitting their evidence or having their cases heard.

- aaa. Richard Hundman: #18-05258-R-1 (Sangamon)

Appellant filed with the PTAB on April 27, 2019 (postmark date) from a board of review decision dated March 27, 2019. On October 3, 2019, the appellant was dismissed for being untimely filed, one day late past the 30-day deadline of Friday, April 26, 2019. On October 25, 2019, counsel entered appearance on behalf of the Appellant and asserts the one-day delay poses no prejudice upon any of the parties, it is possible that a further extension of the deadline could have been secured. The Taxpayer respectfully requests that the above reference appeal be reinstated.

- bbb. Robert Ranquist: #03-25518-C-3 (Cook - Thornton)

Motion to Revive Judgement

Taxpayer's attorney requested the PTAB's decision be revived because the Cook County Treasurer's Office failed to issue a refund in this matter. In the above referenced appeal the PTAB issued a decision reducing the assessment. As of

this date the taxpayer has not received the refund based on the PTAB decision. The taxpayer request the PTAB issue an order reviving the judgement in this appeal so that the Cook County Treasurer's Office will issue a refund of the resulting overpayment.
