envelope bearing a postmark stamp “Springfield, IL P&DC, TUE 14 May 2019 PM”. The submission included an appraisal and a notation dated 5/11/19 directed to the PTAB regarding the above docket number stating, “Enclosed are 2 copies of evidence for above docket #.” On June 20, 2019 the appeal was dismissed due to the evidence being filed one day late based on the 5/14/19 postmark. On July 29, 2019, the PTAB received correspondence from appellant’s attorney and a statement from Michael Gray, Postmaster, dated 7/3/19, asserting that Mr. Hansen stated to him on that date (7/3/19) that he brought the mail piece in question to the Jerseyville Post Office on Saturday, May 11, 2019. The Postmaster asserted that all mail processed at the Jerseyville Post Office is sent to the St. Louis P&DC for processing to be postmarked and sent to its destination for delivery. This mail piece did not receive the required postmark in St. Louis, MO and once the mail arrived at the Springfield, IL, P&DC it was postmarked May 14, 2019.

The appellant’s counsel requested the appeal be reinstated based on the fact the evidence was mailed on May 11, 2019 and should have reflected that postmark date.

Motion to Stay

Appellant’s attorney requests a stay in the proceedings pending a settlement for the 2018 and 2019 assessments for the subject property. Appellant’s attorney asserts that the taxpayer and Board of Review have agreed to stay the proceedings in this matter. Appellant’s attorney asserts he was advised by Andrea Johnson that the Board of Review has agreed to withdraw their previous motion to dismiss for failure to timely file an appeal. The appellant/taxpayer requests the stay until it presents stipulations for a decision at the PTAB meeting before May 14, 2020.
