Chairman Freeman convened the meeting at 10:00 a.m. He welcomed the Board Members and the Management Team to the Property Tax Appeal Board Meeting. A Board Member was present in each of the PTAB offices for the meeting, which was held via WebEx.

2. Approval of Minutes from Previous Meeting

Mr. Bilotta moved to approve the Board Minutes of June 2, 2021, as presented. Chairman Freeman seconded the motion, and it carried 5-0.

3. Adoption or Amendments to the Agenda

Mr. Bilotta moved to adopt the Agenda as presented. Chairman Freeman seconded the motion, and it carried 5-0.

4 Executive Director's Report

Mr. O'Malley reported on the Caseload Highlights: He said that as of 5/24/2021, there were 104,275 open cases. Currently, 107,000 cases are pending. There were 76,537 open cases at the end of FY-20. There are 57,921 cases filed in FY-21, compared to 42,044 opened in FY-20. This FY is likely to see the number of appeals filed exceed 60,000. He said downstate open cases have almost doubled. He further reported on steps taken to address this problem:

- a. Mr. O'Malley said PTAB intends to hire additional staff. We are planning on posting for 2 ALJ jobs in both DPO and SPO for a total of 4. Hopefully, we will also have the funds to bring in one additional support staff member in SPO. It does not help that we are losing office space in Springfield.
- b. Mr. O'Malley reported he met with Katy Straub from CMS Bureau of Administrative Hearings. Katy explained how they were able to help other administrative agencies who had large caseloads. For example, she suggested the DOR could enter an agreement with PTAB where the Department of Revenue (DOR) would hear some of our cases until we get caught up. An ALJ at DOR would take 10 cases a month to write on the evidence. Once O'Malley told her our backlog was at 104,000, she said that would not help. Next, she suggested getting emergency authority to hire hearing officers on a contract basis. I will meet with the State's Chief Labor Negotiator to talk about that at some point. But, our budget has already been set. We have already hired three contract hearing officers this past two months. Finally, she suggested a process where CMS will come in and look at our operations and make efficiency recommendations. There is a Six Sigma standard for government agencies. Mr. O'Malley explained our procedures, and she seemed to think they are efficient. The benefit would be to generate a report to submit to the GA demonstrating that we have done everything we could, and funding is the only option left. Another step we implemented is a "quick call" in Des Plaines. We set about 200 cases for hearing on a quick call with the Cook County Board of Review. Simeon did the first quick call last week, and this was successful. It got the parties talking and settled their cases, and out of all the matters, only four did not settle. Mr. O'Malley further reported we would be doing "the summer project" where we are matching up cases with law firms to get the ball rolling with the Board of Review on negotiations. A fair amount of appeals settled that way too.

Mr. O'Malley provided the HR/Fiscal Update: He reported we are looking to hire a minimum of four hearing officers. Ed Boggess will be retiring on 7/19/21, and we are looking to replace him. He further reported that we are operating within our new budget, which is higher than last year but inadequate to address the backlog. We are still waiting to hear about the additional COVID funds. I understand that negotiations will take place between the Governor and General Assembly. However, I received a recent email, and it doesn't look like we will be receiving those funds; we do not meet the criteria.

Mr. O'Malley provided the IT Update: He reported we would start working with Lake County on a process for their evidence to be submitted electronically.

Mr. O'Malley provided the Legislative and Rule Change Update: He reported our proposed rule changes for virtual hearings had been published for comment for 45 days, without comment. We are now entering the second 45-day notice period.

Mr. O'Malley reported on the All-Staff Meeting: We had a meeting between the SPO and DPO Hearing Officers two weeks ago. Our next all-staff meeting is scheduled for July 22. We will be discussing the role of the Executive Director, Chief Administrative Law Judge, and Deputy Chief Administrative Law Judge as it relates to assigning, reassigning, and replacing hearing officers on cases.
