- 05/20/2024-The appellant files an appeal petition based on a recent appraisal and requests an extension of time to file evidence.
- 06/20/2024-PTAB grants an extension of time until 09/18/2024.
- 09/16/2024-The appellant files its evidence and certifies the filing is complete.
- 10/03/2024-PTAB notifies the Cook County Board of Review (Cook CBOR) of the appeal.
- 11/27/2024 & 12/10/2024-The Cook CBOR certifies notice of the appeal was mailed to all taxing districts.
- 09/09/2025-After being granted extensions of time to file evidence, the intervenor files its evidence.
- 09/25/2025-PTAB notifies the parties to the appeal that all evidence has been submitted and the filing period for submission of evidence is closed except for a 30-day period to submit rebuttal evidence.

- 10/23/2025-The appellant submits a Motion for Leave to Amend Petition, with a copy of a proposed amended petition together with proposed evidence to support the amended petition.
- 10/24/2025-The appellant files rebuttal evidence, consisting of the same evidence filed with its proposed amended petition.
- No objection or response to the motion is filed.

Appellant's Motion

In the motion, the appellant seeks to amend the petition to add recent sale as a basis for the appeal, modify its requested assessment to reflect the sale price, and to submit new evidence in support of the sale. The appellant contends as follows:

- Section 1910.30(g) of the PTAB's rules allows additional evidence to be submitted when good cause is shown.
- The subject sold in December 2024 and this appeal was assigned to the buyer during the tax year at issue in the appeal and after the appellant had submitted its evidence.
- The proposed amendment would not cause harm to any party as the sale is mentioned in the intervenor's appraisal. The intervenor's appraiser discloses the sale but asserts there are no recorded documents to evidence the sale.
- A sale of the subject during the tax year at issue is relevant to determining the subject's assessment.

- 10/09/2019-The above appeal is docketed by PTAB, with PIN 19-13-324-009-0000 incorrectly docketed as 19-13-314-009-0000.
- 06/04/2020-PTAB accepts the above appeal, with the erroneous PIN, notifying the appellant and Cook Couty Board of Review (Cook CBOR).
- 02/23/2023-PTAB receives a signed stipulation of assessment by the parties from the appellant, which includes the erroneous PIN.
- 03/21/2023-PTAB issues a decision based on the stipulation submitted by the parties, including the erroneous PIN.
- 12/03/2025-The appellant submits a Request to Vacate Decision and Reissue with Correct PIN.

Appellant's Request

In the appellant's request, the appellant contends as follows:

- PTAB's final administrative decision in this appeal contains an assessment for a PIN that is incorrectly identified, prohibiting the taxpayer from obtaining a refund for the correct PIN.
- PTAB input an incorrect PIN for the property that differs from the petition filed by the appellant. The incorrect PIN used by PTAB is 19-13-314-009-0000 and the correct PIN for this parcel is 19-13-324-009-0000.

- 03/20/2025-PTAB grants a final 90-day extension until 06/18/2025 to submit evidence.
- 06/18/2025-The appellant submits its evidence.
- 07/03/2025-PTAB notifies Adams County Board of Review (Adams CBOR) of the appeal and provides a due date of 10/01/2025 to submit evidence or a written request for an extension of time.
- 10/30/2025-PTAB finds the Adams CBOR in default for not submitting any evidence in the appeal.
- 10/30/2025-PTAB further notifies Adams CBOR that has it not yet filed a certificate of service confirming all taxing bodies have been notified of the appeal as required by Section 16-180 of the Property Tax Code.
- 10/31/2025- Christopher E. Sherer, of Giffin, Winnings, Cohen & Bodewes, P. C., entered an appearance for the Adams CBOR and files a Motion to Vacate Default.
- 11/05/2025 – PTAB's IT Department determined according to the scan of tracking the 07/03/2025, PTAB email sent to the Adams CBOR was opened by

someone at Adams CBOR twice; once on 07/03/2025, at the hour of 8:00 a.m. and again on 07/05/2025, at the hour of 2:00 p.m.

County's Motion

In the motion, the Adams CBOR contends as follows:

- On 10/30/2025, the Adams CBOR received a notice from PTAB regarding the certificate of service that is due. The Adams CBOR acknowledges it has not sent notice to taxing bodies as it has not been notified of the appeal.
- The Adams CBOR contends it does not have a copy of the petition in the appeal due to an administrative error. The Adams CBOR did not open or otherwise become aware of the 07/03/2025 email transmittal of the appeal from PTAB to the Adams CBOR until 10/30/2025.
- The Adams CBOR does not dispute the email was transmitted by PTAB but asserts the notice was not received. The presumption of service by transmission of an email is rebuttable, and, even if technical compliance with rules of service is found to exist, due process nonetheless requires an email recipient to be informed of the legal proceeding.
- Although PTAB might deem service as complete upon transmission of the 07/03/2025 email, that presumption does not override due process requirements or preclude a showing that the document never actually reached the Adams CBOR.
- In support of the motion, the Adams CBOR submits an affidavit of Lisa Gasko, Adams County Supervisor of Assessments, dated 10/31/2025, who certifies that emails from PTAB are received at SOA@adamscountyil.gov, which is monitored by Gasko and someone else in the same office. After being notified on 10/30/2025, Gasko searched the inbox of that email and did not find the

07/03/2025 transmittal. Gasko then requested a search from the county's IT department who discovered the 07/03/2025 that had been deleted. The county's IT department was unable to determine whether the email had been opened before its deletion. Gasko asserts neither she nor anyone in her office recalls receiving or opening the email. Gasko is aware of appeals for the same property for 2022 and 2023 and is involved in negotiations relating to the 2022 through 2025 and later tax years for the property. Gasko speculates the email deleted in confusion over the tax year at issue. Gasko asserts the Adams CBOR has a meritorious defense to the 2024 appeal and seeks a decision on the merits.

- The affidavit establishes that the 07/03/2025 email from PTAB was deleted before being opened or read or the linked document being opened and downloaded due to an administrative error or other excusable reason.
- The presumption of service has been rebutted and due process principles mandate that the default be vacated. The Adams CBOR lacked proper notice of the 2024 appeal.
- This motion is made in good faith and not for any improper purpose or delay. This motion is made to ensure the appeal is decided on the merits rather than by a technical default. No party will suffer undue prejudice by granting the motion.
- The Adams CBOR requests the default be vacated, the appeal be retransmitted to it, and the Adams CBOR be granted 90 days after the retransmission and receipt to file its evidence, and the Adams CBOR be allowed 30 days after the retransmission and receipt of the appeal to notify the affected taxing bodies.

- 02/02/2024-Cook CBOR requests an extension of time, and a 90-day extension is granted.
- 05/14/2024-Cook CBOR files its Notes on Appeal and evidence.
- 05/23/2024-PTAB notifies the parties to the appeal all evidence has been submitted and the filing period for submission of evidence is now closed.
- 11/07/2024-PTAB notifies the parties to the appeal the appeal will be heard upon its merits at a virtual hearing on 01/21/2025 at 10:30 a.m. The notice to the appellant is mailed to the appellant's mailing address identified in the petition.
